Good Afternoon Heidi & Tina,

I have a question regarding our funds for the AIS grant we've been implementing. It turns out that we have come in under budget in the portion of funding allocated towards staff time for year one of our AIS project. Would it be possible to shift these excess funds towards purchasing more aquatic funnel traps for crayfish trapping in year two? Based on how crayfish trapping has gone thus far in year one, we believe that we could target more ponds at one time if we have more than 10 traps. Using our 10 traps we can typically trap at least 2 ponds per week, but with a total of 20 traps we could definitely increase efforts per week.

Please let me know if this shifting of funds would be possible.
