On October 1, 2013 the Lac du Flambeau Town Lakes committee received grant #SPL-297-13 to support the effort of the Lac du Flambeau Town Lakes Committee to design and electronically print maps of Ike Walton Lake, Little Trout Lake, and Long Interlaken Lake as well as maps of the hydrolic flow patterns and a complete water analysis for these lakes. The activities met are listed below.

**Activity 1:** The Tribal Natural Resources Department will enter point intercept data into WDNR excel spreadsheet for the three lakes surveyed in the summer of 2012.

**Deliverable:** Copy of spreadsheet

**Status:** Copies of three spreadsheets are on the disc. A copy of the spreadsheet for Ike Walton Lake is attached as an example. (*Appendix A*)

**Activity 2:** Confirm with vendor the maps that are needed.

**Deliverable:** Contract with Stantec

**Status:** A copy of the contract with Stantec is attached (*Appendix B*)

**Activity 3:** Contract with Stantec

**Deliverable:** Copies invoice and cancelled check.

A draft of the Pokegama Lake plan is included as an example of how the plans for the other nine lakes will be developed which includes Ike Walton, Long Interlaken and Little Trout Lakes. (*Appendix E*)
