RESOLUTION AUTHORIZING PLACEMENT OF WATERWAY MARKERS IN BIG STONE LAKE Following, BY THE TOWN OF THREE LAKES, ONEIDA COUNTY, WISC.

WHEREAS, the Chapter 30 of the Wisconsin Statutes and Chapter 5 of the Department of Natural Resources Administration Code requires enactment of authorizing legislation by any political subdivision of the state desiring to place waterway markers in or near waters of the state; and

WHEREAS, said political subdivision is further required to designate in said authorizing legislation a description and purpose of the waterway markers, and their proposed location; and

WHEREAS, the Town of Three Lakes desires to locate certain waterway markers in Big Stone Lake and Maple Lake, in a general area contiguous to Highway 32, and as a prerequisite to obtaining permission of the Department of Natural Resources, must comply with the above set out requirements.

NOW THEREFORE BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF THREE LAKES, ONEIDA COUNTY, WISCONSIN, that the Town is hereby authorized to establish the within described waterway as a restricted area as designated herein, and is further authorized to place the following described waterway markers pursuant to Chapter 30 of the Wisconsin Statutes and Chapter 5 of the Department of Natural Resources Administrative Code, and as required by the Commandant of the U. S. Coast Guard.

BE IT FURTHER RESOLVED, that the specific area affected herein and the type and numbers of markers authorized is described as follows, to-wit:

Placement of buoys along the South Shore of Big Stone Lake to extend from the bridge on Highway 32 to a point 2,000 feet East; these buoys will be 200 4985 from shore and will encompass a Water Ski Slalom Course; these buoys will be white and extend 36 inches above the water and be properly marked with the Orange Triangle and lettered WATER SKI AREA.

The Map attached hereto shows the described area where buoys will be placed.
