 This Unnamed Lake is a diverse lake including the land surrounding the lake. Big Sand Lake a premier tourist lake is across the road. (Thompson Bay Road) This area of Burnett County has many lakes and public landings. There is also State of Wisconsin land with a trail head and trails used for recreation across the road. (Thompson Road) This area is an unspoiled tourist attraction. I feel naming this lake is a benefit to the county and state as it will lead to increased awareness, tourism, and property values in the area.

 The origin of the recommended name is from oral history of locals in the area. Two property owners I spoke with on Thompson Bay Road refer to it as Truck Lake, as well as a business owner on County Road A. The "rumor" is there is a truck at the bottom of the lake, supposedly from the Capone days. While I can't confirm the existence of the truck (I have looked while in my canoe) I can confirm these conversations with locals who have lived in the area their entire lives.

Hi David,

I have a few questions regarding the lake name change. First is the location. There is no unnamed lake 1/4 miles west of Sand Lake. Following the sections numbers the lake in question would be in the Keizer Lake area owned by the Conservation Commission and is part of the proposed land trade with Burnett County. This would be some 5 miles west of Sand Lake. To make an accurate response we would need more information on the location of the lake. The most logical lake given the section 30 location is actually Bannock Lake due to its relationship to roadways. In any event please provide more detailed information on the location. It is doubtful that naming a lake in public ownership would aid local property values.

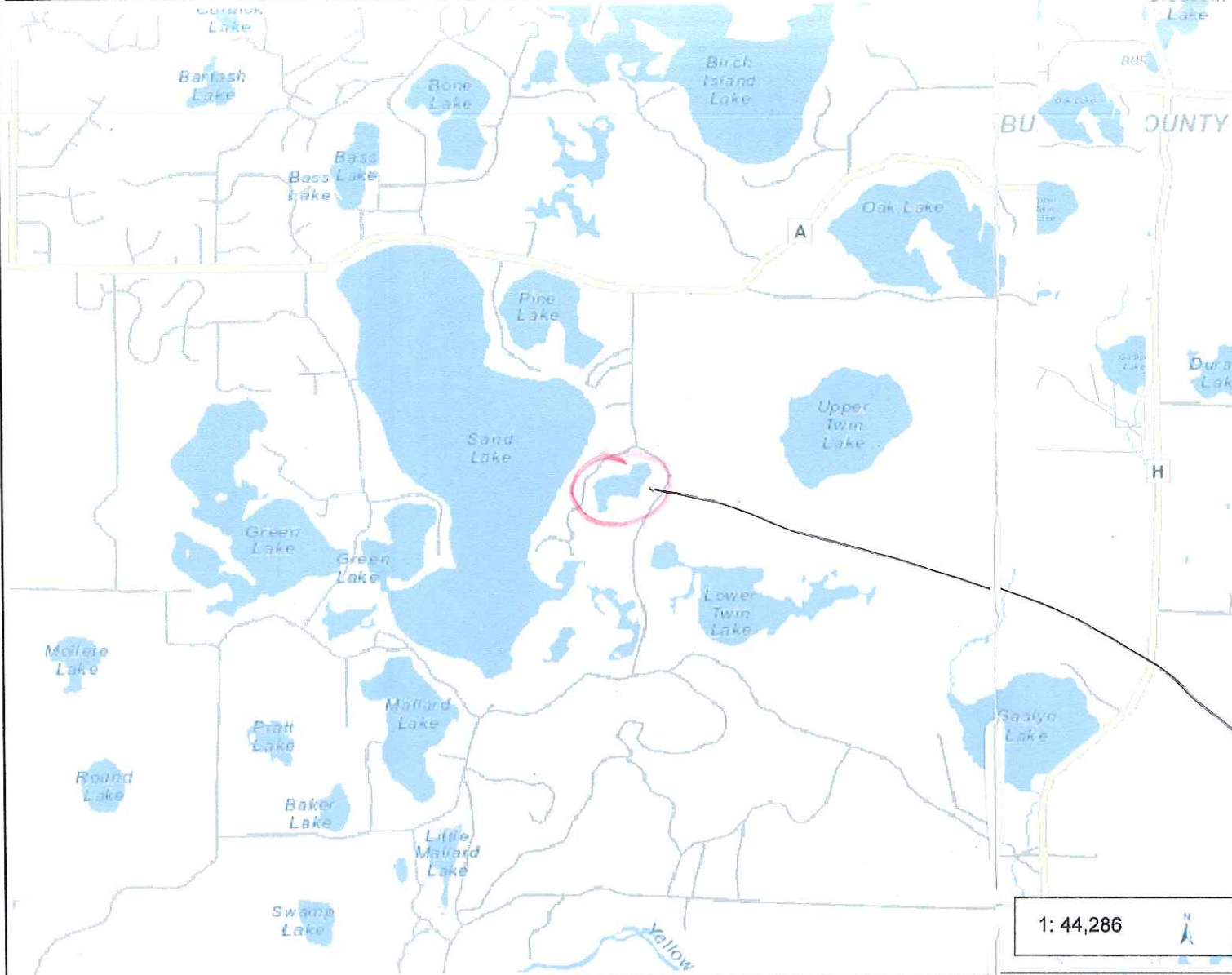

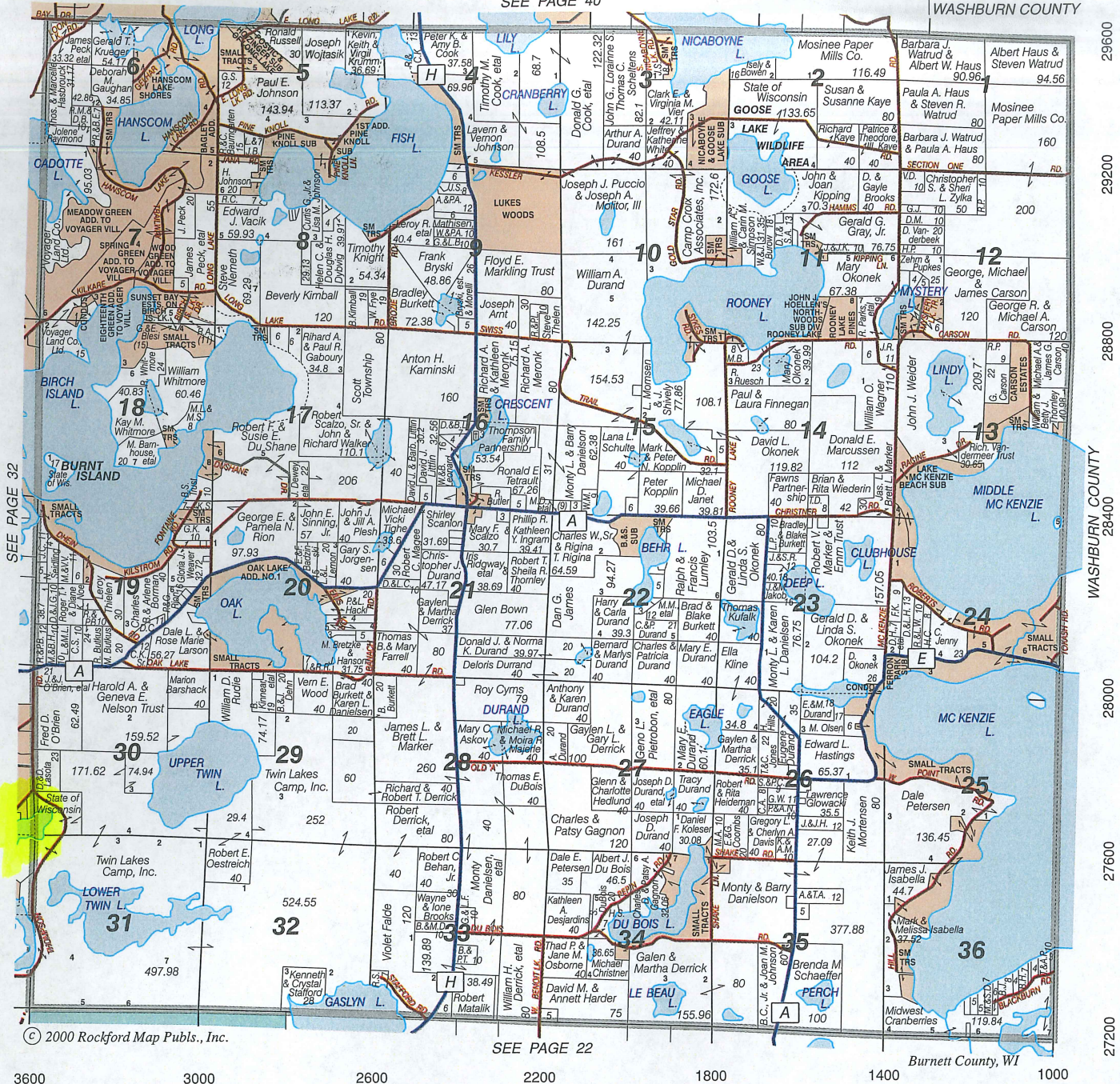

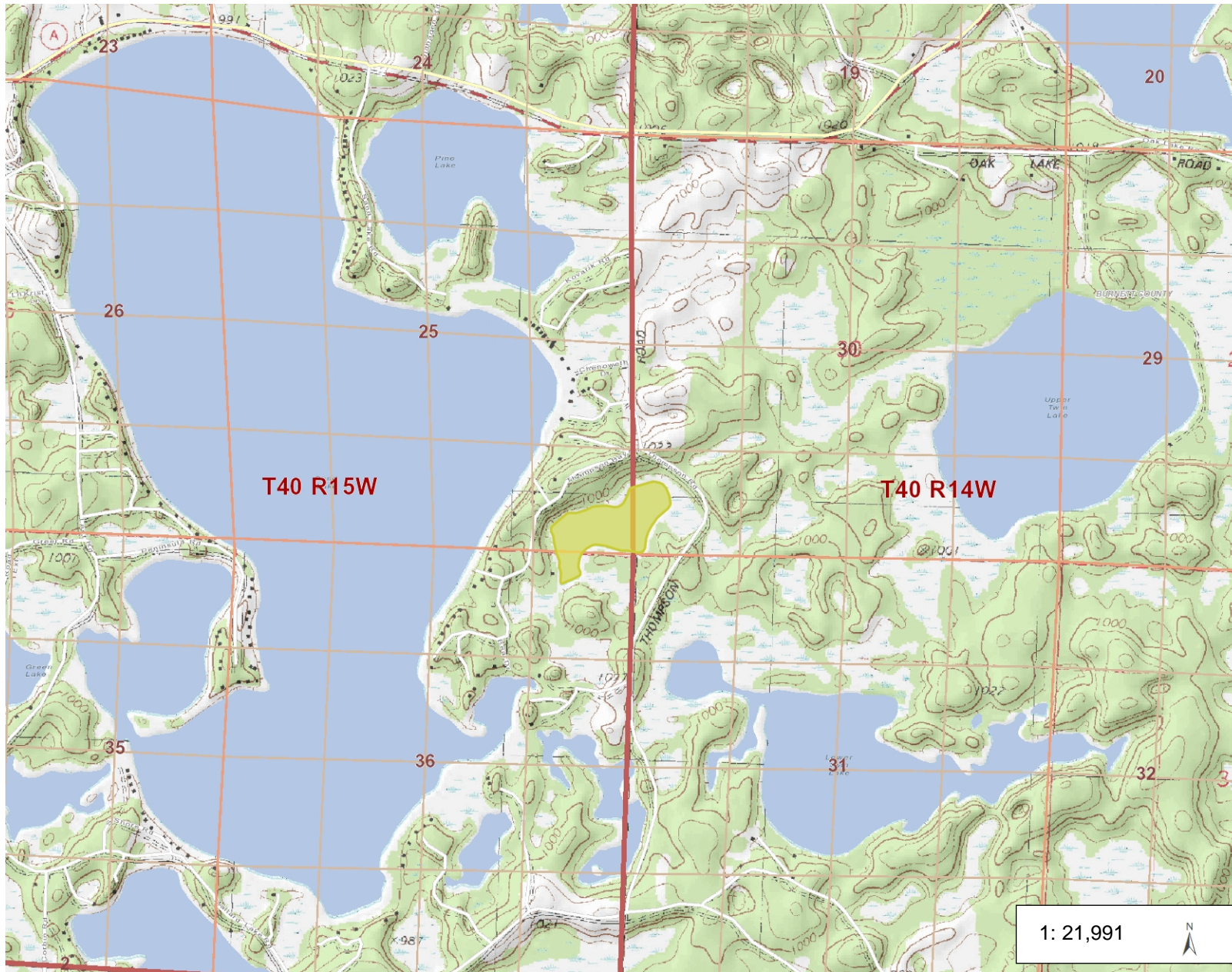
