

This form is designed to tell us where you have placed your purple loosestrife biocontrol insects, as well as give us important information about the receiving wetland. You are the only one who can give us this valuable information. And since purple loosestrife is a state-restricted plant under NR-40 regulations, reporting where you put loosestrife plants for distributing biocontrol beetles is required by law, (please report all biocontrol insect releases, even if not on potted plants). Use a GPS unit for latitude and longitude data and reading accuracy and/or describe the location completely. Estimate the numbers as best you can (e.g. a football field is ~ 1 acre). Thank you for your important contribution to the health of Wisconsin's wetlands!
