Friends of Hika Bay Planning Spring/Summer Activities

The Friends of Hika Bay look forward to “formally” adopting Hika Park and Fischer Creek Park in 2015, helping care for the park’s continued invasive species control and habitat enhancements.

The volunteer citizen-based group formed in April 2011 and created a five-year action plan to guide and prioritize activities that began in 2012. Early efforts focused on water quality monitoring of area creeks in collaboration with the Lakeshore Water Institute at UW-Manitowoc and the restoration of Centerville Creek. Since that time, the group moved into invasive species management and habitat restoration along with maintaining the water quality monitoring.



This year, the group needs more volunteers for trail maintenance, habitat improvement, invasive species control, and planting in the newly created swale/wet-meadow system in the Hika Shores property.

The group helps advise Village staff; raise awareness of stewardship needs to improve our quality of life, bring educational seminars to the Cleveland community; and bring their passion for land and water quality improvement to greater Manitowoc County.

Their work plan builds on extensive water quality monitoring that began on Fischer and Point Creeks in 2005 as well as four years of water quality monitoring on Centerville Creek from 2010-2014. In 2015, they will monitor 10 sites on Centerville Creek with two student interns from UW-Manitowoc.

The project is being supported by the Lakeshore Natural Resource Partnership (LNRP) that provides general project support, fiscal management, and guidance on the planning and coordination of seminars, workshops, and events.

VILLAGE PRESIDENT'S MESSAGE

In February, I attended the annual meeting for the Cleveland Fire Department. In 2014, the Fire Fighters responded to 48 fire calls and the First Responders provided emergency medical services 86 times. Over 3,300 hours of volunteer time was given by responding to calls and routine and mandatory training. We are very fortunate to have this very dedicated group of people serving our community, 24 hours a day, 7 days a week!

I am pleased to report that the Village Board unanimously approved a budget retaining the same tax levy as the previous year. As in your own households, the Village sees increases in utilities, supplies, and insurances, to name a few. The Village also will be receiving less in shared revenue from the state, which will again result in your municipality doing more, with less revenue. One change you will notice, the Village has contracted with T&L Services of Cleveland, to provide lawn cutting services. This will allow the Village to reduce our equipment costs and to reallocate our workers to better take advantage of their training and specialized knowledge.

In 2015, the Village will be making the final payment on the 20 year debt for our Wastewater Treatment plant. We will be conducting a facilities study to determine the condition of

the equipment at the plant and to provide us with a timeline for future equipment updates or replacements. We will also be working with our accountants on how to handle the repayment of funds that the village advanced to the utility many years ago. We need to inquire if there are any proposed regulations that the state and DNR working on and what effect will they have on our plant operations. As you can see, there is much information to gather and analyze before adjusting our utility rates. We must plan for the future of our utilities, so they can continue to provide our residents with safe drinking water and an efficiently operating wastewater treatment plant.

For those of our residents who travel Lakeshore Road to Sheboygan, you can see the road project was not completed as planned in 2014. I am thankful it is open for traffic during these months, but anticipate the new road project to be completed by summer, as the PGA will be returning to Whistling Straits in August.

CENTERVILLE BRICK OVEN BREAD

In days gone by, on farms and in villages, every scrape had a purpose. Sheep were raised to provide wool for knitting clothing and quilts. Chickens laid eggs and their meat was consumed. Cow's milk was a popular drink and was also an ingredient in cooking and baking. Cream was churned to butter but, best of all, could also be made into ice cream. The meat (beef) was a favorite, those big juicy hamburgers! With all this yummy eating, bread was a necessary staple. In the Town of Centerville there were several outdoor bake ovens. The Centerville Historical Society has been privileged to be permitted to use a historic oven to bake bread. In yester years, bread was baked in these outdoor oven located within an out building. This was done so that the farmhouse itself would not become overheated on warm summer days. When the Historical Society bakes bread, the dough is set the evening before and let to rise. Early in the morning a wood fire is started in a metal pan, which is then placed into a brick lined oven so as to warm the oven to 400-500 degrees. In the morning the dough is shaped into round loaves and let to rise again. By midmorning the bread is ready to be baked. The metal pan with the hot coals is removed. A large wooden paddle with a long handle (5 to 6 feet) is used to place the bread into the oven directly onto the hot bricks. Approximately 25-30 loaves of bread are baked at one time. When baked, this bread has a beautiful golden brown crust and is baked to perfection on the inside. Years ago bazaars were held and bread was a popular item to sell.

Our gratitude to the family for preserving the oven so this tradition can continue.

Police Department

GENERAL INFORMATION

The Village Board, in an effort to save costs, last year funded all officer positions at casual (less than part-time) status. The Police Commission at its 2014 meeting was concerned with the negative impact on local police services and recommended the Village Board restore one officer position to full-time. The Village Board accepted this recommendation and Officer Katzka was reinstated from casual to full-time status as of January 1, 2015. Officer Schuessler continues to teach the D.A.R.E. program at Cleveland Elementary and provide some internal training, but reported last year he would be unavailable for field work. Officer Schweigl was subsequently hired at casual status to address this reduction in field hours and is currently participating in field training with Chief Barber and Officer Katzka.

SCHOOL IS OPEN

Remember, the speed limit in a school zone is 15 MPH when children are present, Monday through Friday, 8:30AM to 4:30PM. The speed signs will be set up as a reminder during school hours. The fines double for speeding in a school zone when children are present. Also, remember to stop for school bus flashing lights!

Hika Park Enhancements Continue

Friends of Hika Bay have continued to work to enhance Hika Park with a focus on the Hika Shores Conservation Area. A constructed berm was planted with clover and rye grass along with cedar trees this past spring. In the existing swale, both a mix of sedge seeds as well as individual plants were planted this spring with the plants responding quite well to what have been good growing conditions. The plugs included lake sedge, tussock/hump sedge, deflexed bottle-brush sedge, and Bebb's sedge.

Wooded dune and swale complexes are found along the shoreline of all of the Great Lakes. These complexes are documented from Wisconsin, Minnesota, Michigan, Illinois, Indiana, Pennsylvania, Ohio, and the province of Ontario.

Ridge swale complexes are best developed where streams provide a dependable sand source. The combination of along-shore currents, waves, and wind form foredunes along the shoreline where they contain a unique assemblage of physiographic, soil, and vegetative components, and provide

a high quality habitat for numerous shoreline animal and bird species.

Protecting hydrology is important in the maintenance of vegetative structure in wooded dune and swale complexes. Invasive, non-native species such as *Lythrum salicaria* (purple loosestrife), *Phalaris arundinacea* (reed canary grass), and *Phragmites australis* (giant bulrush) can also invade the wet swales.

A community gathering was held on Sunday, July 19th, hosted by the LNRP, to celebrate and appreciate the volunteers and friends of Hika Bay. A beautiful Wisconsin summer day, folks enjoyed a BBQ and an interpretive walk showcasing the work that was done in Hika Bay.

Another volunteer day is planned for Saturday, September 26 where additional work is planned on planting islands of wildflowers on the berm, managing invasive species, and cleaning the beach. If interested, contact Jenn Hansmann at Jenn@lnrp.org or 920-627-1799.

The Story of a Dam on Centerville Creek

The original dam on Centerville Creek was built over 150 years ago, providing power for a grist mill and water for the volunteer fire department. During its lifetime, the dam suffered extensive structural damage, so extreme in the 1940s that the mill's turbine ended up in Lake Michigan.



Citizens mobilized to rebuild, wanting to keep the dam's recreational and firefighting functions. They held a fundraiser and drew generous contributions (including from the Izaak Walton League), and enjoyed the pond for many years. Unfortunately, it filled with sediment and became less and less viable for fish. The ice was unpredictable due to springs and seepage. The Department of Natural Resources considered the concrete structure a danger to the downstream bridge along Lakeshore Drive and mandated that the Village repair or remove the dam. After much community discussion, the Village Board decided the only affordable choice was its removal.

Afterward, the creek waters cut a new channel in the deep sediment. Instead of gradual banks, the sides of the creek were vertical, at some points over 10 feet deep. The canyon-like walls partially collapsed, dropping sediment into the creek and creating murky waters that flowed into Lake Michigan. Reed canary grass and other invasive plants dominated the sediment surface and most fish couldn't survive. Groundwater seeps caused weak spots, creating "quicksand"-like conditions, making it dangerous for public use.

The Village Board commissioned studies to determine options for restoration and safety. A breakthrough came when Lakeshore Natural Resource Partnership obtained grant monies to design and construct a restored waterway. Sediment was removed and restoration techniques, including woody barriers and stone riffles, re-created natural systems to restore the meandering creek. Fish returned to a healthy creek for the first time since the initial dam was built in 1864.

The project's success is due to the efforts of many individuals including members of the Plan Commission, Village Board, and LNRP. Citizen volunteers continue work on invasive species,

and plant trees and other restorative flora along the banks and shoreline. All in all, a tremendous achievement for Cleveland!

Dear Cleveland Residents,

As you drive by or visit Lakeshore Technical College, you may notice some construction in the coming months. There are some exciting things happening at LTC.

We are nearing completion of a Campus Facilities Building on the east end of campus that will house equipment and our Maintenance Department staff. The metal pole building is slated for completion by the end of March. By vacating the space in the lower level of our current Agriculture and Energy Building, additional instructional space becomes free.

This space is important to our upcoming building project, the Advanced Auto Technology Center to house the Auto Collision Shop and the Auto Maintenance Shop. The expansion will offer capacity for more students, more lifts and additional work training stations.

Since the Auto program introduction in the mid 1970's, the automotive maintenance and repair industry has evolved in the areas of technology, engineering designs, materials, processes and regulations, and there are many improvements needed to bring programs up-to-date.

The 14,000 square foot space vacated by the facilities area moving to the east end of campus will be remodeled and used for the Auto Collision program. Simultaneously, the 13,000 square feet vacated by the Auto Collision program will be remodeled to accommodate the expansion of the Auto Maintenance Program. Both projects are slated to begin May 1st. The entire project is slated for completion in late October.

An expansion and renovation of the automotive educational facilities will achieve an improved, modern learning environment, equipped with technology relevant to today's best practices in auto care. A capital campaign is underway to fund the \$3.9 million project.

Since only 4 of 28 area high schools offer auto maintenance and no high schools offer collision repair classes, local employers rely on Lakeshore Technical College as a primary resource for skilled technicians. Industries hire graduates of LTC's auto program at a rate between 96 and 100 percent.

We look forward to the completion of this project so we can fill this local workforce need effectively. As your neighbor, we will continue to keep you updated or answer any questions you may have.

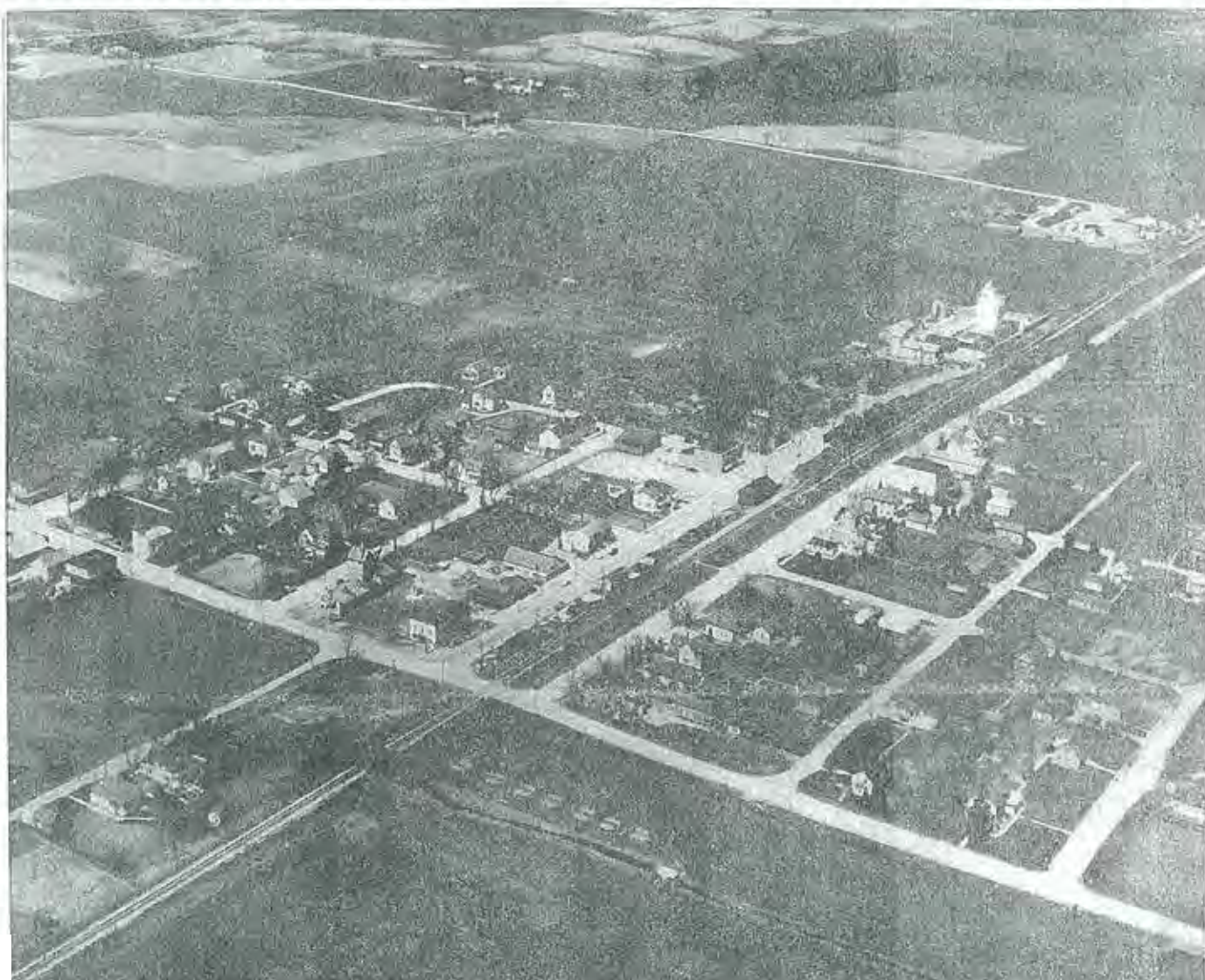

IT'S BEEN DONE BEFORE

In the village of Cleveland, pictured above, on March 3rd of this year the first edition of *The Clevelander* went to press and the entire community was surprised and appreciative of the action taken by the Cleveland Chamber of Commerce.

95% of the community businessmen became sponsors of the venture with a board of directors consisting of Gilbert Belitz, president, Merlin Matthias, Arno Thomas, Edwin A. Wagner and Karl Omsted forming the nucleus and entered into a thirteen week contract to support the paper.

The *Clevelander* is not the very first paper to be published in this community as in the year 1908 Erwin G. F. Gartzke of Hika published a little news magazine called the "*Cleveland-Centerville Review*", front page of which is reproduced partially here. Mr. Gartzke was 18 years of age and after completing four issues he met a tragic death by drowning on July 10, 1908 in the Centerville Dam; it also marked the death of a community paper until The *Clevelander* arrived forty-five years later.

The Gartzke publication was in the form of a magazine pamphlet containing a review of the month, short stories, poetry, ads and many short human interest topics. In his fourth and last issue we find many interesting ads such as **HAVE your RAZORS, SCISSORS and KNIVES sharpened**, R. H. Hinz, the Barber, Hika; **GEORGE SCHUETTE**, dealer in fresh, salt meats and fine sausages, Centerville, etc.

In the Review of the Month section we find this amusing report — The chicken thief, who was in our community some time ago, has just been convicted and sentenced to one year at Wau-pun and — On June 21st a bus load of boys and girls from Centerville went on a pleasure trip to Silver Lake. Unable to travel further by team, they got off and walked the last four or five

After much community discussion, the Village Board decided the only affordable choice was its removal.

Afterward, the creek waters cut a new channel in the deep sediment. Instead of gradual banks, the sides of the creek were vertical, at some points over 10 feet deep. The canyon-like walls partially collapsed, dropping sediment into the creek and creating murky waters that flowed into Lake Michigan. Reed canary grass and other invasive plants dominated the sediment surface and most fish couldn't survive. Groundwater seeps caused weak spots, creating "quicksand"-like conditions, making it dangerous for public use.

The Village Board commissioned studies to determine options for restoration and safety. A breakthrough came when Lakeshore Natural Resource Partnership obtained grant monies to design and construct a restored waterway. Sediment was removed and restoration techniques, including woody barriers and stone riffles, re-created natural systems to restore the meandering creek. Fish returned to a healthy creek for the first time since the initial dam was built in 1864.

The project's success is due to the efforts of many individuals including members of the Plan Commission, Village Board, and LNRP. Citizen volunteers continue work on invasive species, and plant trees and other restorative flora along the banks and shoreline. All in all, a tremendous achievement for Cleveland!

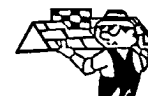

Greater Centerville Historians

At present the Greater Centerville Historians are unable to meet. If anyone is willing to help organize the meetings, please contact Kirsten Husband, 693-8302.

Since the late 1840's there had been a brewery in Centerville. The first brewery burned down in the 1880's at the time when making harbor improvements was the big issue. It was located on the corner of Birch and Washington Street in Hika. It was not until 1890 that the brewery was rebuilt. A new company was formed which was a cooperative venture, with local people. It went bankrupt in two years. In 1899 the Garzke Brothers bought the brewery and operated it until 1914. The building was torn down, and there has been no further effort to conduct such a business in the village. Incidentally, the bricks from the old brewery were used to build the Mikadow Theater in Manitowoc.

SUMMER SEWER RATES: From the May 25 - September 28 water meter readings (July 1 - October 1 water/sewer bills), the Sewer Utility will charge only for the average amount of water consumed December 1 through the May meter reading. This adjustment reflects the increased use of water for summer activities, such as gardening and pools, where the water does not enter the treatment system. The Water Utility will charge for all water used.

YARD WASTE SITE HOURS: CLOSED MONDAYS - Tuesday through Sunday, 7:30am – 8pm. Availability is weather dependent, and the site may close on occasion for maintenance. Call Public Works, (920)693-8236, and leave a message with your contact information if you have an extensive yard project outside of regular hours. With sufficient notice, we can coordinate access for you or your contractor.

GRASS CLIPPINGS: Do not mow grass into the street. Grass clippings and yard waste plug storm sewers, leading to water backups and flooding. Please rake material out of the grate to drain the water if plugged. If that doesn't work, call Village Hall at (920)693-8181.

BUILDING PERMITS: Building permits are generally required for building improvements, adding permanent or temporary structures or fencing, and completing repairs. Due to the volume of requests, it is recommended you allow a minimum of FIVE business days from the time a building permit application is dropped off until approval; TEN business days for building additions, new homes, and commercial or institutional projects. Applicants for projects involving new buildings or expansions, or changes in use, should meet with Village staff early in the planning process. Contact Village Hall at (920)693-8181 to make an appointment. The application form is available on the Village website, www.clevelandwi.gov, and can be left in the Village Hall drop box. Remember, fees double if work is started without a permit.

OPEN BOOK/BOARD OF REVIEW: The assessment roll will be open for examination on June 27, 4:30pm to 6:30pm, at Village Hall. Board of Review will meet July 20, 5pm to 7pm, to hear and decide objections.

Hika Park Updates

Hika Shores Restoration

The final steps in the construction of a community similar to a ridge swale ecosystem will be completed at the Hika Shores property this spring. The constructed berm was planted with trees last year along with treatment for invasive species. This spring the berm was planted with a clover-rye mix and will be overlaid later this spring with a mix of wildflowers. The swale was excavated last fall and will be planted this spring with a sedge meadow mix.

Pedestrian Bridge, Viewing Platform, and Interpretive Trails

Bids will be going out this spring for the construction of a pedestrian bridge that will link the southern and northern parcels of Hika Park. The bridge will create safe passage from the boat landing to the Hika Shore

property. The project will provide better access to the Hika Shores natural area and more Lake Michigan frontage than is currently available.

The project emerges from a successful restoration of the abandoned millpond on Centerville Creek that is adjacent to Hika Park. The Village of Cleveland expanded Hika Park to include the restored stream channel and an adjacent ridge-swale community. The park increased in size from 2.21 acres to 13.85 acres.

The project will fulfill goals originally identified in the Village of Cleveland's 1985 Waterfront Plan, further refined in the 1998 Hika Park Plan, and the 20-Year Comprehensive Plan completed in 2007.

For the long-term maintenance of the park, Friends of Hika Bay has formally adopted the park as part of the Village of Cleveland's Adopt-A-Park program. FOHB has cultivated a dedicated group of volunteers that will provide community support for the long-term sustainability of this very valuable community resource.

LNRP and Partners Receive *Phragmites* Control Grant

LNRP along with partners Stantec Environmental Consultants, the Manitowoc County Lakes Association (MCLA), and the Lakeshore Invasive Species Management Area (LISMA), recently received a DNR *Phragmites* Control Grant to reduce this rapidly spreading invasive.

The spread of *Phragmites* in Manitowoc County has reduced access to beaches and riverfronts for recreational activities such as swimming and fishing, restricted lakefront views, and damaged walkways and structures along the beachfront.

Phragmites currently occurs as small to large scattered populations along the Manitowoc County shoreline; however, if left untreated, dense stands will spread relatively quickly along the shoreline and inland tributaries.



This project intends to build upon previous control efforts along the Lake

Michigan shoreline and tributaries by expanding the treatment project area to areas where treatment has historically not occurred, and by working to educate landowners on the need for continued treatment beyond the scope of this 3-year project.

This project will treat *Phragmites* within private and public lands, and is working towards treating 100% of the Lake Michigan shoreline in Manitowoc County.

Hika Park Enhancements Continue

Friends of Hika Bay have continued to work to enhance Hika Park with a focus on the Hika Shores Conservation Area. A constructed berm was planted with clover and rye grass along with cedar trees this past spring. In the existing swale, both a mix of sedge seeds as well as individual plants were planted this spring with the plants responding quite well to what have been good growing conditions. The plugs included *lake sedge*, *tussock/hump sedge*, *deflexed bottle-brush sedge*, and *Bebb's sedge*.

Wooded dune and swale complexes are found along the shoreline of all of the Great Lakes. These complexes are documented from Wisconsin, Minnesota, Michigan, Illinois, Indiana, Pennsylvania, Ohio, and the province of Ontario.

Ridge swale complexes are best developed where streams provide a dependable sand source. The combination of along-shore currents, waves, and wind form foredunes along the shoreline where they contain a unique assemblage of

physiographic, soil, and vegetative components, and provide a high quality habitat for numerous shoreline animal and bird species.

Protecting hydrology is important in the maintenance of vegetative structure in wooded dune and swale complexes. Invasive, non-native species such as *Lythrum salicaria* (purple loosestrife), *Phalaris arundinacea* (reed canary grass), and *Phragmites australis* (giant bulrush) can also invade the wet swales.

A community gathering was held on Sunday, July 19th, hosted by the LNRP, to celebrate and appreciate the volunteers and friends of Hika Bay. A beautiful Wisconsin summer day, folks enjoyed a BBQ and an interpretive walk showcasing the work that was done in Hika Bay.

Another volunteer day is planned for Saturday, September 26 where additional work is planned on planting islands of wildflowers on the berm, managing invasive species, and cleaning the beach. If interested, contact Jenn Hansmann at Jenn@lnrp.org or 920-627-

Partners Implementing First Year of *Phragmites* Control Grant

Manitowoc County partners -- the Lakeshore Natural Resource Partnership, Stantec Environmental Consultants, the Manitowoc County Lakes Association (MCLA), and the Lakeshore Invasive Species Management Area (LISMA)-- have mapped invasive *Phragmites* along the Lake Michigan shoreline and right of ways in coastal townships. As phase one of a three-year effort, they are seeking permission for access to both public and private lands.

Phragmites occurs widely as small to large scattered populations along the Manitowoc County shoreline. If left untreated, dense stands will spread relatively quickly along the shoreline and inland tributaries. The invasive, nonnative *Phragmites* can grow over 16 feet tall and expand more than 50 feet each year through stolons or runners. This extremely aggressive plant displaces native plants, takes over wetland and riparian habitats, and reduces wildlife use. It can also decrease recreational opportunities, property values, and block your view of Lake Michigan.

Restore the Shore

LNRP first got involved with significant restoration projects more than five years ago with the Centerville Creek Restoration Project in the Village of Cleveland. The project since was expanded to include integrating the Hika Shores property purchased by the Village in 2005 into the existing Hika Park, which offers the only lake-level boat landing between Sheboygan and Manitowoc. Hika Park has long hosted the popular annual Cleveland Fish and Game Fish Derby.

This year, we are finishing Phase 5 of 5 by constructing a pedestrian bridge, a lakefront viewing platform, and a series of strategically-placed interpretive signs throughout the park.

Our *Restore the Shore* initiative is now forging ahead with additional enhancements at Fischer Creek Park, collaborative work with the Glacial Lakes Conservancy at the Point Creek Conservation Area, a *Phragmites* Control Grant for Manitowoc County



partnering with the Manitowoc County Lakes Association, and the Door County Forest Recovery Project.

What emerged from our multi-year and -faceted experience is the value of creating a local friend group that formally adopts the park to help maintain it through invasive species management, restoration plantings, and general clean up but, most importantly, a committed long-term partner.

This year, Friends of Hika Bay is celebrating the completion of a restoration process that now has expanded Hika Park from its original 2.2 acres to almost 14 acres.

In the last few years, LNRP has helped facilitate a similar process with the Friends of the Manitowoc River Watershed who formally adopted Lower Schuette Park and informally adopted the 10 public beaches in the City of Manitowoc. This community-based Friend group has already completed an invasive species checklist in the park and worked with the Lakeshore Invasive Species Management Area (LISMA) to combat *Phragmites* on the Manitowoc River.

This year, the Friends partnered with the City of Manitowoc to install a kayak canoe launch at the park. Members also conduct two beach clean-ups per year on all 10 beaches in Manitowoc, one centered around Earth Day in April and one completed in association with the Alliance for the Great Lakes annual beach clean-up in September.

In 2015, LNRP began helping build capacity for the Friends of Crescent Beach in Algoma, our newest partner. The Friends formally joined LNRP this spring and already have created an action plan that includes hosting a beach kite flying celebration and a series of outreach activities co-sponsored by the Algoma Chamber of Commerce. The group is already working with the City of Algoma to leverage funding to implement a completed environmentally-engineered beach restoration plan.

These experiences demonstrate how critical citizen involvement is to creating successful public-private partnerships but, perhaps more importantly, how critical this engagement is to sustain the restoration at public parks and natural areas for the long term.

LNRP is now looking to create a similar community-based partnership with the further development of the Little Manitowoc River Partnership. LNRP has helped leverage significant funding to restore the Little Manitowoc's coastal wetland with an overall design that incorporates management of what could become the Little Manitowoc Conservancy. The nearly 250-acre conservancy would bring under one management umbrella the Little Manitowoc Prairie, the Little Manitowoc Walkway, Lincoln Park Zoo, and Indian Creek Park. The conservancy would have inter-linked trails that would connect to the heavily used Mariner's Trail.

A second call to action is for partners looking to engage a stronger youth presence in stewardship activities.



Toward this goal, LNRP is working with partners throughout the lakeshore to better engage our youth to cultivate a land and water ethic. Through a process that combines hands-on activities with opportunities for education, we're hoping to better prepare the next generation for the challenges that will arise to help sustain a high quality of life.

Over the last few years, LNRP helped create the Lakeshore Water Institute with UW-Manitowoc which hires 3-5 interns each year to focus on water quality monitoring and reporting their findings back to the public through an annual Water Summit each fall.

In Door County, we are forging ahead with plans to celebrate stewardship and the good works being done by the county's significant number of active community

groups. We are planning a spring 2016 event to create an opportunity for youth to engage with these groups in a day of interactions, chronicled through storytelling via song, painting, and other forms of artistic expression.

The Vickie Mayer Youth Conservation Program hosted by the Friends of the Branch River Watershed has created a curriculum designed to advance students through three steps of awareness, stewardship, and action.

The Friends of Twin Rivers are engaging four area schools to train teachers with Water Action Volunteers (WAV) and helping coordinate the water quality monitoring on the East Twin River and West Twin River.

And just recently, LNRP has initiated conversations with partners in Sheboygan County to host a celebration of stewardship that focuses on conservation priorities and mobilizes a network of community volunteers aspiring to engage youth groups in the area as part of our collaborative work in protecting and conserving the special places we will collectively prioritize.

LISMA Landowner Workshop: *Managing the Invasive Species on Your Private Land*

A landowner workshop hosted by the Lakeshore Invasive Species Management Area (LISMA), Saturday January 9 at Woodland Dunes Nature Center in Two Rivers, brought together eight LISMA steering committee members (including the LISMA coordinator), two guest speakers, and 19 private landowners to network and collaborate on invasive species issues around the area.



Attendees came from Manitowoc, Fond du Lac, Kewaunee, Calumet and Brown counties to learn more about invasive species identification, control, electronic mapping and tracking tools and funding opportunities. Speakers included Tony Summers, coordinator of the Wisconsin First Detector Network, featuring several mapping tools, including the IPC connect app; Matt Rataczak, Natural Resource Conservation Service District Conservationist, who addressed the numerous cost sharing options available for private landowners; Diane Schauer, Calumet County Aquatic Invasive Species coordinator, covering invasive species identification and updates to Wisconsin Statute NR 40; and Jennifer Powell, land management coordinator at Woodland Dunes and LISMA coordinator, concerning invasive species control and habitat restoration efforts at Woodland Dunes.

Participants appreciated the opportunities to network during breaks and lunch, as well as the question and answer session following lunch. By early afternoon, folks had a packet of identification materials and a better understanding of who to contact for help with invasive species issues in their area.

First Year of *Phragmites* Control on the Lake Michigan Shoreline

The partnership that formed to apply and manage funding from the Wisconsin DNR to control *Phragmites*, implemented their first year of treatment on both private and public lands in Manitowoc County on the Lake Michigan Shoreline. Areas were mapped earlier in 2014 and revisited in 2015 along with getting landowner permission prior to treatment.

The group plans to contact additional landowners in 2016 to make treatment as comprehensive as possible, planning to treat upstream on the frontal watersheds adjacent to Lake Michigan. The partners are also working with the Manitowoc County Highway Department to seek rapid response grants for treatment on Right-of-Ways where new populations have emerged. Partners include LNRP, LISMA, the Manitowoc County Lakes Association (MCLA), and Stantec Consulting Services.

Restore the Shore Receives Significant Funding

The lands and waters of the Lakeshore recently received a boost of financial support when LNRP was awarded two grants for our Restore the Shore efforts. Freshwater Future and the USFWS Coastal Program contributed to our plans for invasive species management and restorative planting at Fischer Creek Park and Hika Park in southern Manitowoc County as well as supporting the efforts of our watershed partners.

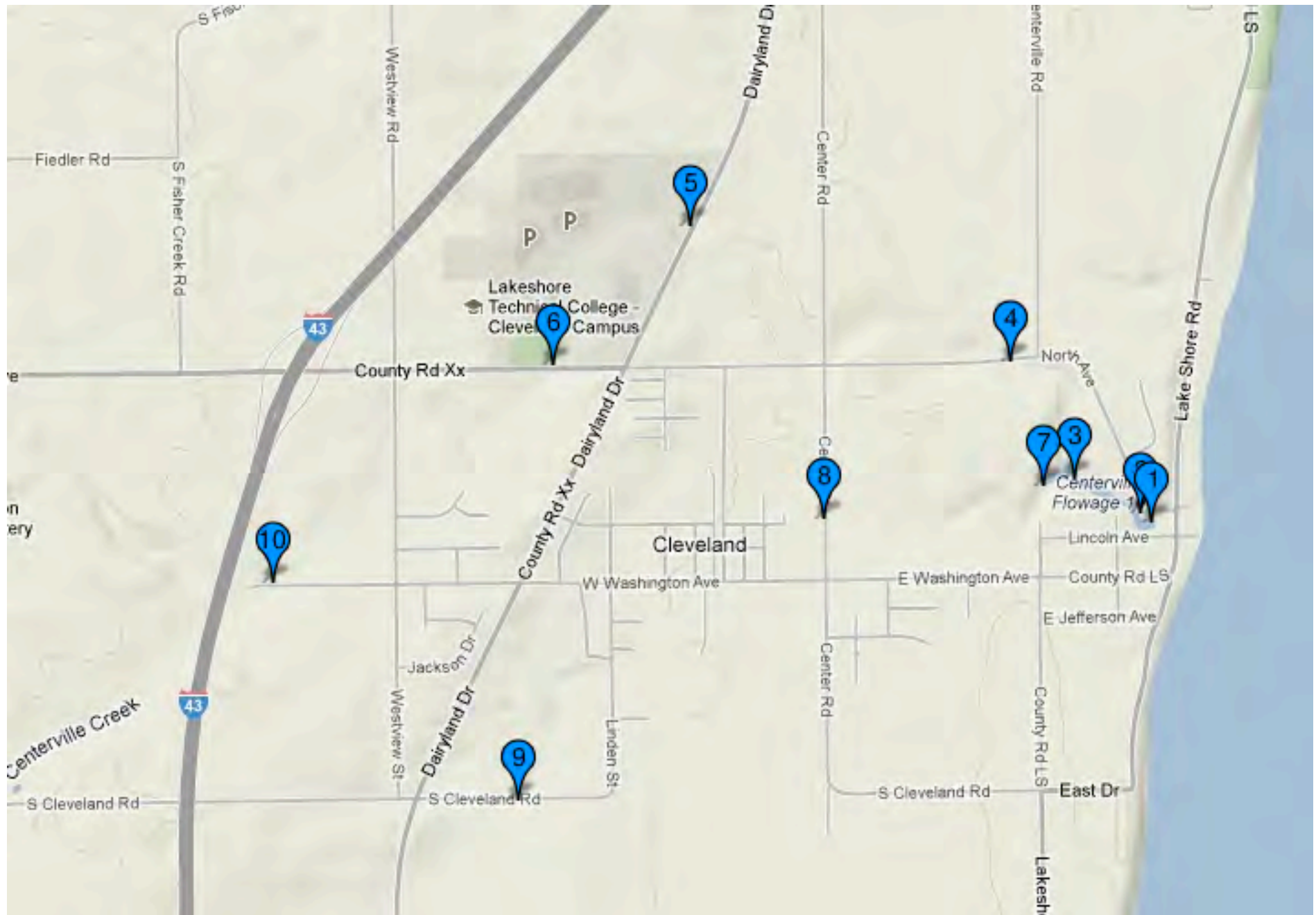
Freshwater Future contributed \$1,500 to support additional enhancements to the kayak launch that the Friends of the Manitowoc River Watershed installed at Lower Schuette Park on the Manitowoc River (*see related story in this issue*) and our work in restoring the coastal wetland of the Little Manitowoc River.



The USFWS contributed \$25,000 for habitat enhancements for migratory birds on the Lake Michigan shoreline. The grant is in collaboration with the Woodland Dunes Nature Center in Two Rivers who received an additional \$25,000.

This funding is designed to support the environmental community in the Great Lakes and protect and restore water quality and natural habitats in the Lake Michigan basin.

Centerville Creek Water Quality Sampling Points: 2010 through 2015

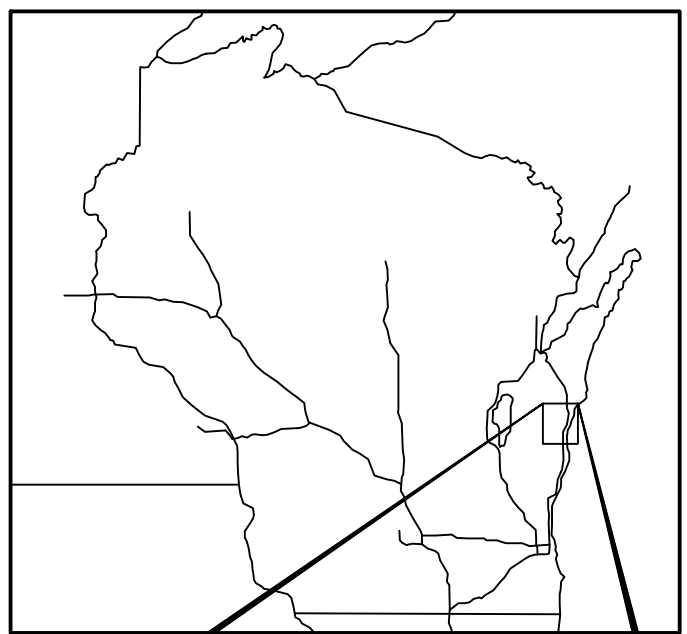

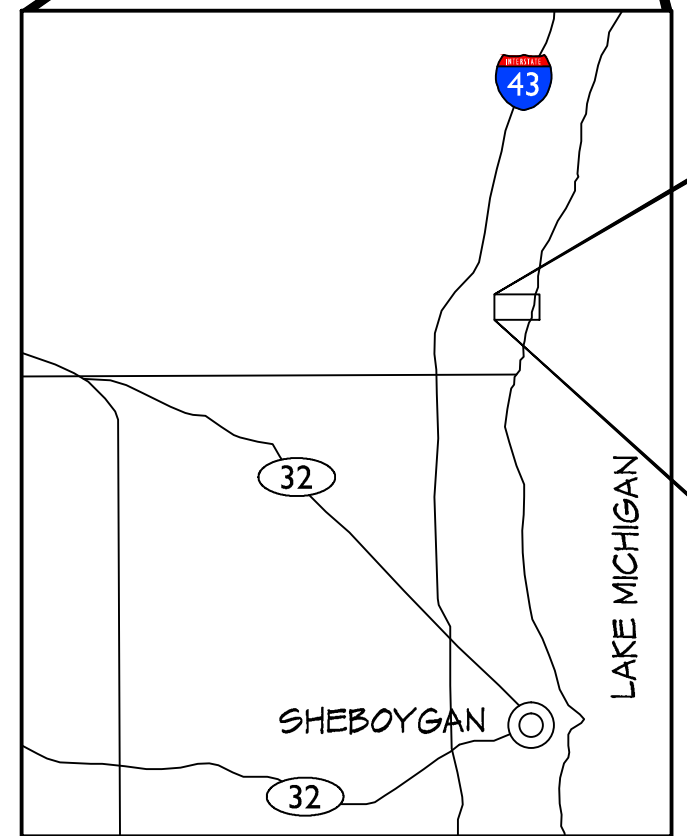

4. THE SURFACE FABRIC TREATMENT LOCATIONS (SHEETS 3 AND 4) SHALL RECEIVE ONLY THE INNER FABRIC PLACEMENT AS SHOWN ON THIS SHEET AND TYPICAL CROSS SECTION S (SHEET 8).

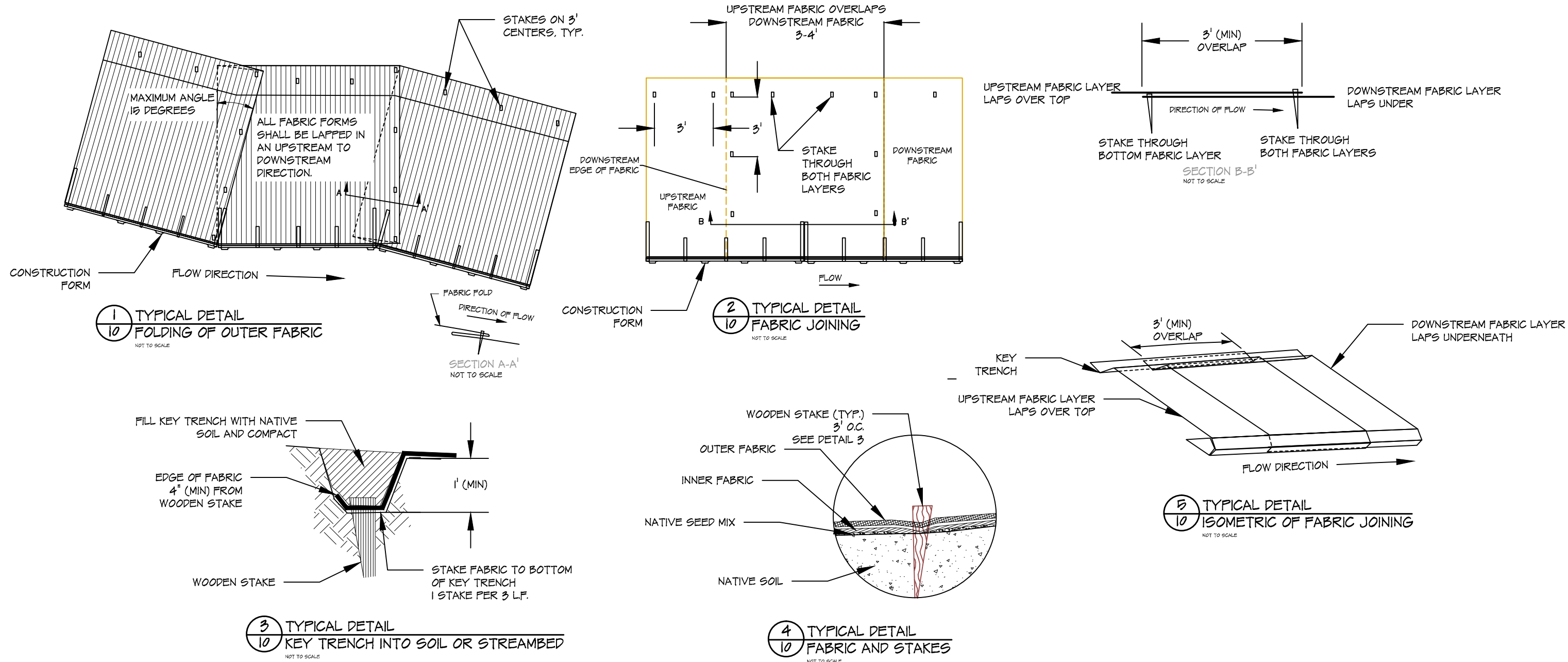

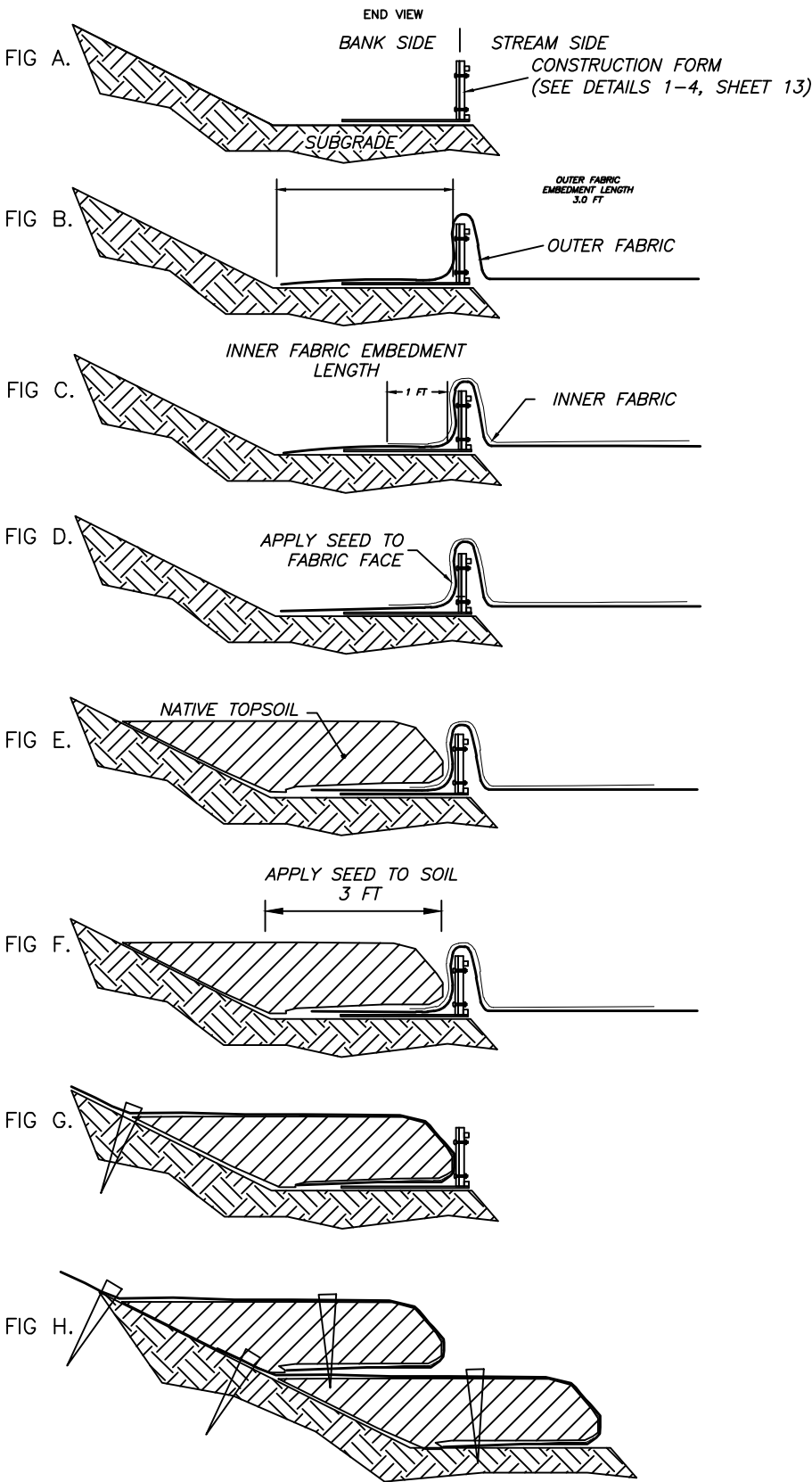

1. SECURE THE BANK SIDE EDGE OF THE OUTER FABRIC WITH A WOODEN STAKE THROUGH THE FABRIC ON 3 FOOT CENTERS (SEE DETAIL VIEWS 1 AND 2). NOTE: THE HOLES FOR THE STAKES SHALL NOT BE PRECUT. ALLOW THE STAKE TO BREAK THE MINIMUM NUMBER OF STRANDS AS IT IS BEING DRIVEN. DRIVE STAKES SO THAT 2" TO 3" OF THE STAKE IS LEFT EXPOSED
2. 12 INCH NORTH AMERICAN GREEN ECOSTAKES SHALL BE PLACED ON 18 INCH CENTERS EXCEPT WHERE WOODEN STAKES HAVE BEEN PLACED.
3. FORMS MAY BE ANGLED TO CREATE BENDS IN THE LIFTS AS NEEDED. FABRIC SHALL BE FOLDED AT EACH BEND AS SHOWN IN DETAIL 1. NO BEND SHALL EXCEED A 15 DEGREE ANGLE. FOLDS SHALL BE MADE IN AN UPSTREAM TO DOWNSTREAM DIRECTION. STAKE THE FOLDS AS SHOWN IN SECTION A-A'.
4. OUTER FABRIC ENDS SHALL BE JOINED BY LAPPING THE UPSTREAM PIECE OF FABRIC OVER THE DOWNSTREAM PIECE AS SHOWN IN DETAIL 2. OVERLAPS SHALL BE A MINIMUM OF 3 FEET. INNER FABRIC ENDS SHALL BE BUTTED TOGETHER, NOT OVERLAPPED. OVERLAPS SHALL BE STAGGERED FROM LIFT TO LIFT BY A MINIMUM OF 15 FEET.

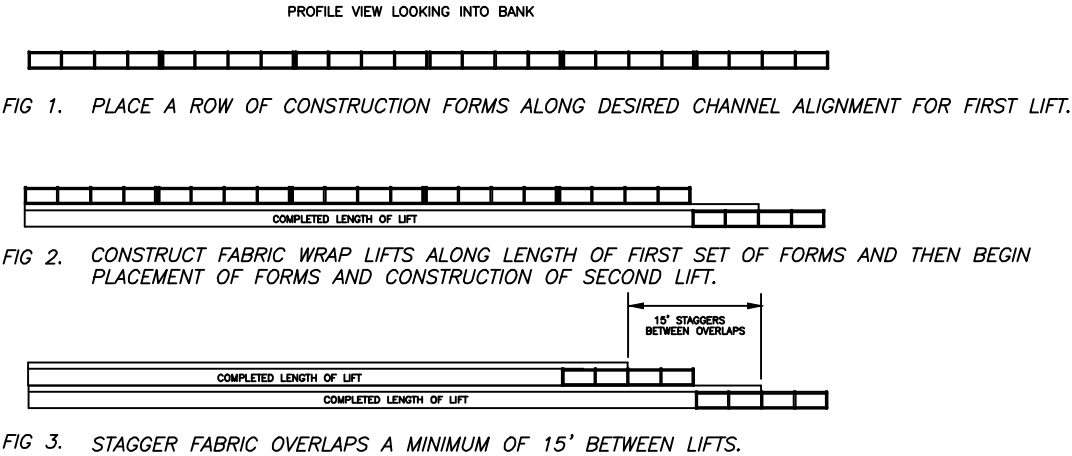

GENERAL INSTRUCTIONS FOR FABRIC ENCAPSULATED LIFTS

1. BANKS MAY BE CONSTRUCTED IN EITHER AN UPSTREAM OR DOWNSTREAM DIRECTION, AS LONG AS THE FABRIC IS OVERLAPPED IN THE PROPER DIRECTION.
2. PLACE A SERIES OF THREE OR MORE FORMS ON THE GROUND SO THAT THE FORMS FOLLOW THE PROPOSED STREAM BANK ALIGNMENT. BUTT THE ENDS OF THE FORMS TIGHTLY TOGETHER.
3. UNROLL THE OUTER FABRIC PARALLEL TO THE LONG AXIS OF THE CHANNEL AND POSITION IT SO THAT 3 FEET EXTENDS FOR EMBEDMENT ON THE BANK SIDE OF THE FORMS (FIG B), AND A MINIMUM 3 FEET EXTENDS LENGTHWISE BEYOND THE LAST FORM FOR OVERLAP. DRAPE THE REMAINDER OF THE FABRIC OVER THE TOP OF THE FORMS ON THE STREAM SIDE (FIG B).
4. UNROLL THE INNER FABRIC OVER THE TOP OF THE WOVEN COIR FABRIC (FIG B) AND POSITION IT SO THAT AT LEAST 1 FOOT OF THE INNER FABRIC EXTENDS AS AN EMBEDMENT LENGTH ON THE BANK SIDE OF THE FORMS (FIG C). DRAPE THE REMAINDER OF THE FABRIC OVER THE TOP OF THE FORMS ON THE STREAM SIDE AND ALIGN THE LONG EDGES OF THE FABRICS. STRETCH AND PULL THE FABRIC LAYERS TO REMOVE WRINKLES.
5. APPLY NATIVE SEED MIX TO INNER FABRIC ALONG VERTICAL EDGE OF LIFT (FIG D), PLACE SPECIFIED FILL OVER THE FABRIC ON THE BANK SIDE OF THE FORMS. LEVEL THE FILL AND COMPACT TO 85-90 PERCENT RELATIVE COMPACTION (FIG E).
6. APPLY NATIVE SEED MIX TO TOP OF FILL FROM THE FRONT OF THE LIFT TO 3 FT BACK FROM FRONT OF THE LIFT (FIG F).
7. FOLD THE LOOSE ENDS OF THE TWO COIR FABRIC LAYERS BACK OVER THE COMPACTED FILL MATERIAL AND STRETCH TIGHTLY TO REMOVE WRINKLES (FIG G). SECURE WITH WOODEN STAKES 1 PER 3 L.F. ALONG THE BACK EDGE AND INTO UNDISTURBED SOIL.
8. REMOVE THE FORMS FROM THE FRONT OF THE COMPLETED LIFTS (FIG. 2). LEAVE THE LAST FORM IN PLACE AT THE END OF THE NEWLY CONSTRUCTED LIFT (FIG. 2). CAREFULLY RESET THE FORMS ON TOP OF THE FINISHED LAYER FOR THE NEXT LIFT (FIG H).
9. PROCEED WITH A NEW SERIES OF LIFTS BY EXTENDING A NEW ROW OF FORMS. BEGINNING AT THE END FORM THAT WAS LEFT IN PLACE, LAY OUT TWO NEW LAYERS OF FABRIC AS PREVIOUSLY DESCRIBED, MAKING SURE TO OVERLAP THE NEW FABRIC LAYERS WITH THE PREVIOUS LAYERS. STAGGER OVERLAPS, BETWEEN ADJACENT LIFTS BY A MINIMUM OF 15 FEET (FIG. 2).
10. ON THE TOP LIFT, EXCAVATE A KEY TRENCH 15 FEET WIDE AND 1 FOOT DEEP ALONG THE EDGE OF THE OUTER FABRIC LAYER, PARALLEL TO THE FORMS. SEED ENTIRE AREA OF TOP LIFT. SECURE FABRIC IN THE KEY TRENCH WITH WOODEN STAKES, 3 FT O.C.
11. BACKFILL THE KEY TRENCH WITH TOPSOIL AND CONTINUE TO APPLY TOPSOIL TO SMOOTHLY MERGE WITH EXISTING CONTOURS. APPLY NATIVE SEED MIX TO KEY TRENCH AREA.
12. SUPPLEMENT LIFT STAKING WITH ADDITIONAL STAKES (FIG. H). INSPECT INSTALLATION FOR AREAS OF LOOSE FABRIC OR LOCATIONS OF VOIDS BETWEEN FABRIC AND SOIL. ADD STAKES OR WOOD STAPLES TO ENSURE FABRICS ARE TIGHT AND IN SOLID CONTACT WITH UNDERLYING SOIL.

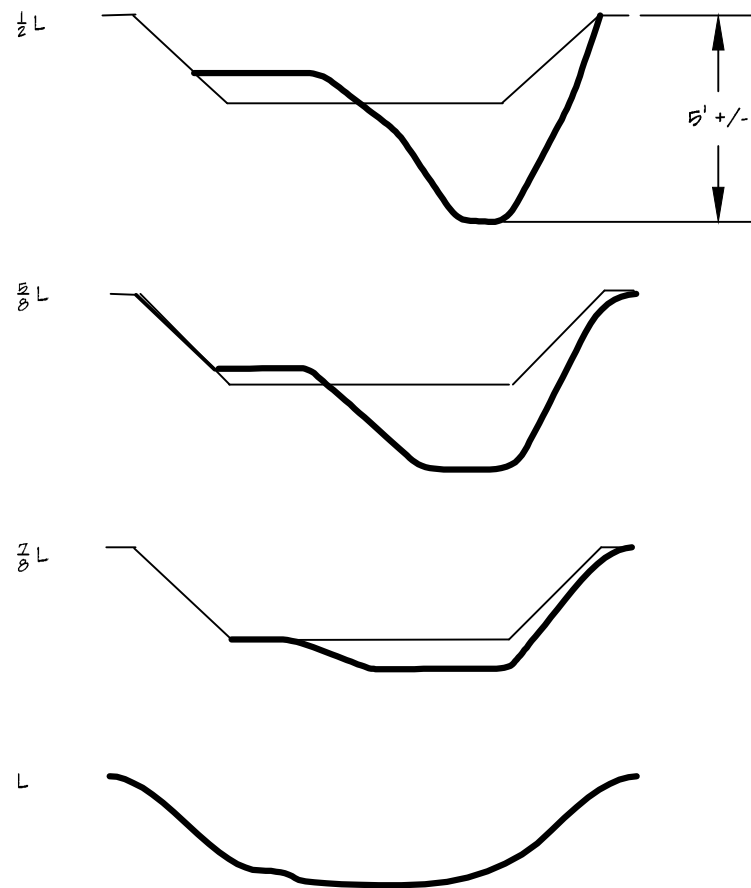

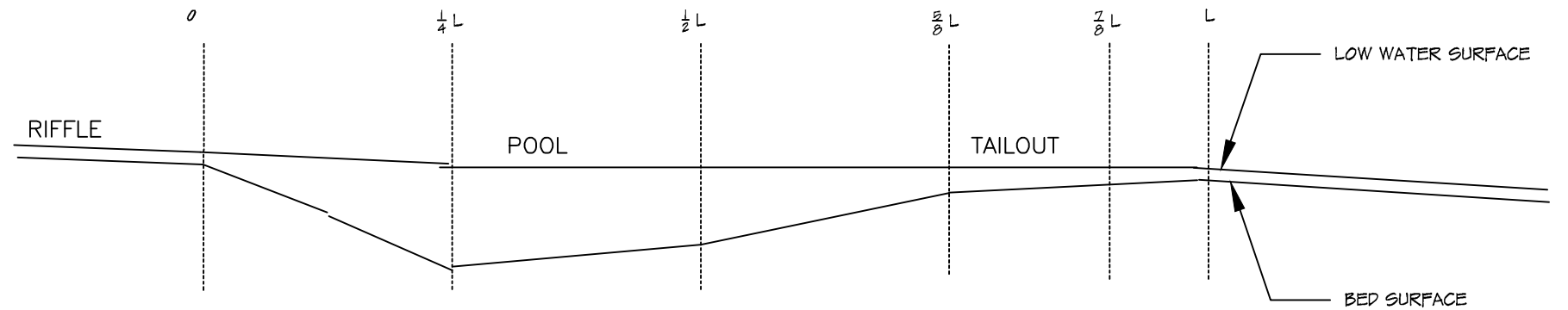

SILT FENCE NOTES:

1. THE FILTER FABRIC SHALL BE PURCHASED IN A CONTINUOUS ROLL CUT TO THE LENGTH OF THE BARRIER TO AVOID USE OF JOINTS. WHEN JOINTS ARE NECESSARY, FILTER CLOTH SHALL BE SPLICED TOGETHER ONLY AT A SUPPORT POST, WITH A MINIMUM 6 INCH OVERLAP, AND BOTH ENDS SECURELY FASTENED TO THE POST. ALTERNATIVELY, OVERLAP AND INTERLOCK TWO POSTS WITH ATTACHED FABRIC AS APPROVED BY THE OWNER'S REPRESENTATIVE.
2. THE SILT FENCE IS TO BE INSTALLED ALONG THE DOWNHILL PERIMETER OF DISTURBED AREAS. THE FENCE POST SHALL BE SPACED A MAXIMUM OF 6 FEET APART AND DRIVEN SECURELY INTO THE GROUND A MINIMUM OF 24 INCHES APART.
3. THE FILTER FABRIC SHALL HAVE A MINIMUM VERTICAL BURIAL OF 6 INCHES. ALL EXCAVATED MATERIAL FROM SILT FENCE INSTALLATION SHALL BE BACK-FILLED AND COMPACTED ALONG THE ENTIRE DISTURBED AREA.
4. STANDARD OR HEAVY DUTY SILT FENCE SHALL HAVE MANUFACTURED STITCHED LOOPS FOR 2 INCHES X 2 INCHES POST INSTALLATION.
5. SILT FENCES SHALL BE REMOVED WHEN THEY HAVE SERVED THEIR USEFUL PURPOSE, BUT NOT BEFORE THE UPSLOPE AREA HAS BEEN PERMANENTLY PROTECTED AND STABILIZED, OR AS DIRECTED BY THE OWNER'S REPRESENTATIVE.

1. CONSTRUCTION NOTES

- 1.1. CONSTRUCTION WILL OCCUR IN AN EXISTING STREAM BED WITH FLOWING WATER, BOTH EXCAVATION AND FILL OF MATERIAL WILL BE REQUIRED TO MATCH THE GRADES SHOWN ON THE PLANS. THE CHANNEL AND ADJACENT EXCAVATED MATERIAL MAY PRESENT A CHALLENGE TO FILL PLACEMENT AND GENERAL CONSTRUCTION GIVEN THE WATER CONTENT. SUBMITTAL OF A CONSTRUCTION OPERATIONS PLAN INCLUDING A DEWATERING PLAN OR MEANS TO DIVERT WATER AROUND ACTIVE CONSTRUCTION IS REQUIRED.
- 1.2. CONSTRUCTION SHOULD OCCUR BETWEEN JUNE 1 AND SEPTEMBER 1.
- 1.3. CONTRACTOR IS RESPONSIBLE FOR VERIFYING ALL QUANTITIES LISTED.
- 1.4. CONSTRUCTION LIMITS WILL REMAIN WITHIN THE LIMITS OF DISTURBANCE OUTLINED ON PAGES 2, 3 AND 4.

2. SURVEY CONTROL

- 2.1. TEMPORARY PROJECT BENCHMARKS RELATIVE TO THE ASSUMED PROJECT DATUM HAVE BEEN INSTALLED BY INTER-FLUVE. THE CONTRACTOR SHALL USE THESE TEMPORARY BENCHMARKS AS THE BASIS FOR VERIFICATION OF GRADES, AND SUPPLEMENT THESE AS NECESSARY TO COMPLETE THE WORK.

3. CLEARING

- 3.1. APPROXIMATE LOCATIONS OF TREES TO BE REMOVED OR SAVED ARE INDICATED. OWNER'S REPRESENTATIVE WILL MAKE FINAL DETERMINATIONS IN THE FIELD WITH THE CONTRACTOR PRIOR TO START OF CONSTRUCTION.

4. UTILITIES

- 4.1. THE CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR HAVING UTILITIES LOCATED PRIOR TO CONSTRUCTION ACTIVITIES.
- 4.2. THE CONTRACTOR SHALL IMMEDIATELY CONTACT THE AFFECTED UTILITY SERVICE TO REPORT ANY DAMAGED OR DESTROYED UTILITIES. THE CONTRACTOR SHALL PROVIDE EQUIPMENT OR LABOR TO AID THE AFFECTED UTILITY SERVICE IN REPAIRING UTILITIES AT NO COST TO THE OWNER.

5. EQUIPMENT

- 5.1. ALL EQUIPMENT SHALL ARRIVE ON SITE CLEAN AND FREE OF FLUID LEAKS, MUD, OIL, GREASE, AND ANY OTHER ORGANIC MATERIAL. OWNER WILL INSPECT EACH PIECE OF EQUIPMENT UPON ENTERING THE STAGING AREA.
- 5.2. ANY HYDRAULIC EQUIPMENT OPERATING WITHIN 30 FEET OF THE STREAM SHALL USE A NON-PETROLEUM BASED HYDRAULIC FLUID.
- 5.3. THE CONTRACTOR IS SOLELY RESPONSIBLE FOR PROVIDING A SPILL CONTAINMENT AND CONTROL PLAN WITH NOTIFICATION PROCEDURES INCLUDING AN OIL-ABSORBING, FLOATING BOOM WHENEVER SURFACE WATER IS PRESENT, SPECIFIC CLEANUP AND DISPOSAL INSTRUCTIONS FOR DIFFERENT PRODUCTS, QUICK RESPONSE CONTAINMENT MEASURES THAT WILL BE AVAILABLE ON THE SITE, PROPOSED METHODS FOR DISPOSAL OF SPILLED MATERIALS, AND EMPLOYEE TRAINING FOR SPILL CONTAINMENT.
- 5.4. DIAPER ALL STATIONARY POWER EQUIPMENT (I.E., GENERATORS, PUMPS, CRANES, ETC.) OPERATED WITHIN 150 FEET OF ANY STREAM, WATER BODY OR WETLAND TO PREVENT LEAKS, UNLESS SUITABLE CONTAINMENT IS PROVIDED TO PREVENT POTENTIAL SPILLS FROM ENTERING ANY STREAM OR WATER BODY.
- 5.5. BEFORE OPERATIONS BEGINS AND AS OFTEN AS NECESSARY DURING OPERATION, PRESSURE WASH ALL EQUIPMENT THAT WILL BE USED BELOW ORDINARY HIGH WATER UNTIL ALL VISIBLE EXTERNAL OIL, GREASE, MUD, AND OTHER VISIBLE CONTAMINANTS ARE REMOVED.
- 5.6. ALL REFUELING OPERATIONS SHALL OCCUR ONLY IN THE STAGING AREA OR OFF SITE.

6. DEWATERING

- 6.1. STREAM DIVERSION AND DEWATERING TO BE ACCOMPLISHED IN STRICT ACCORDANCE WITH ALL APPLICABLE PERMITS AND REGULATIONS.
- 6.2. WATER SHALL BE DIVERTED AROUND AREAS OF ACTIVE EXCAVATION BY USE OF TEMPORARY WATER CONTROL BARRIERS UPSTREAM AND DOWNSTREAM OF THE AREA, AND CONVEYANCE OF WATER AROUND THE WORK AREA USING OFFLINE CONSTRUCTION, PIPING OR OTHER MEASURES. UTILIZE PUMPS AS NEEDED TO DIVERT FLOWS.
- 6.3. CONTROL BARRIERS SHALL BE CONSTRUCTED OF JERSEY BARRIERS, ENVIRONMENTAL BARRICADES, SAND BAGS, BULK BAGS (SUPER SACKS) OR OTHER TEMPORARY MATERIALS TO BE SUBMITTED FOR APPROVAL BY THE ENGINEER.
- 6.4. DIVERSION STRUCTURES AND SYSTEMS SHALL BE CONSTRUCTED AND MAINTAINED IN A MANNER THAT PREVENTS EROSION.
- 6.5. WHEN UTILIZED AS A SOLE MEANS OF MOVING WATER AROUND THE DIVERSION, PUMPING SYSTEMS SHALL HAVE ADEQUATE CAPACITY TO MAINTAIN THE DIVERSION DURING STORM EVENTS. BACKUP PUMPS OF EQUAL CAPACITY SHALL BE ON HAND DURING STORM EVENTS FOR CONTINGENCY UTILIZATION.
- 6.6. DIVERSION PUMP DISCHARGE LOCATIONS SHALL BE ADEQUATELY PROTECTED FROM EROSION AND SCOUR BY USE OF RIPRAP, PLASTIC SHEETING, GEOTEXTILES, PLYWOOD, OR OTHER APPROVED.
- 6.7. LOCAL DEWATERING: MEASURES SUCH AS LOCAL PUMPS SHALL BE EMPLOYED TO REMOVE WATER FROM WITHIN THE ACTIVE WORK ZONE. WATER ENTERING THE ACTIVE WORK ZONE SHALL BE PUMPED TO A TEMPORARY SEDIMENT POND, FILTRATION MEASURES SUCH AS A DIRTBAG, OR VEGETATED INFILTRATION AREA TO MINIMIZE TRANSPORT OF SUSPENDED MATERIAL.
- 6.8. PUMPED WATER SHALL BE ALLOWED TO INFILTRATE BACK INTO THE SOILS OR OTHERWISE FLOW OVERLAND THROUGH ESTABLISHED VEGETATION IN A MANNER THAT PREVENTS EROSION DELIVERY OF WATER TO DOWNSTREAM SOURCES AND/OR SATURATES ANY PREVIOUSLY WORKED SOILS.
- 6.9. ALL STREAM DIVERSION AND DEWATERING MATERIALS AND MEASURES SHALL BE REMOVED UPON PROJECT COMPLETION. AREAS AFFECTED BY STREAM DIVERSION AND DEWATERING SHALL BE RESTORED TO PRE-PROJECT CONDITIONS, OR BETTER.

7. CONSTRUCTION ACCESS AND STAGING

- 7.1. THE CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR PROVIDING TRAFFIC CONTROL AND SIGNAGE IN ACCORDANCE WITH STATE AND LOCAL REQUIREMENTS
- 7.2. THE CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR SITE SECURITY.
- 7.3. EROSION AND SEDIMENT CONTROLS AT CONSTRUCTION INGRESS AND EGRESS SHALL BE KEPT FREE OF DEBRIS AND IN FUNCTIONING CONDITION DURING THE DURATION OF THE PROJECT.

8. EROSION AND SEDIMENT CONTROL

- 8.1. CONTRACTOR IS RESPONSIBLE FOR COMPLYING WITH ALL LOCAL, STATE, AND FEDERAL PERMIT AND REGULATORY REQUIREMENTS RELATED TO EROSION AND SEDIMENT CONTROL ON SITE.
- 8.2. SINCE WORK WILL OCCUR IN AN ACTIVE STREAM CHANNEL, EROSION CONTROL WILL FOCUS ON STAGING AND ACCESS PATHS TO THE CHANNEL AS WELL AS DEWATERING AND EXCLUSION OF ACTIVE CONSTRUCTION AREAS FROM FLOW.
- 8.3. CONTRACTOR IS RESPONSIBLE FOR DAILY INSPECTION AND MAINTENANCE OF ALL EROSION CONTROL PARAMETERS ON SITE.
- 8.4. AT STORM DRAIN LOCATIONS ADJACENT TO INGRESS/EGRESS AND FUELING AREAS, INSTALL BMPS TO PROTECT DRAINS AND PREVENT DELIVERY OF POLLUTANTS.
- 8.5. SILT FENCE, WHEN APPLIED, SHALL CONFORM TO WI DOT STANDARDS, REMAIN MAINTAINED THROUGHOUT THE CONSTRUCTION PROJECT AND BE REMOVED UPON COMPLETION OF THE PROJECT OR STABILIZATION OF THE SITE, AT THE OWNER'S DISCRETION.
- 8.6. DURING THE CONSTRUCTION PERIOD, EROSION CONTROL FACILITIES SHALL BE UPGRADED BY THE CONTRACTOR AS NEEDED FOR UNEXPECTED STORM EVENTS AND TO ENSURE THAT SEDIMENT AND SEDIMENT-LADEN WATER DO NOT LEAVE THE SITE.
- 8.7. INSPECTION OF EROSION CONTROLS: DURING CONSTRUCTION, MONITOR INSTREAM TURBIDITY AND INSPECT ALL EROSION CONTROLS DAILY DURING THE RAINY SEASON AND WEEKLY DURING THE DRY SEASON, OR MORE AS OFTEN AS NECESSARY, TO ENSURE THE EROSION CONTROLS ARE WORKING ADEQUATELY.
- 8.7.1. IF MONITORING OR INSPECTION SHOWS THAT THE EROSION CONTROLS ARE INEFFECTIVE, MOBILIZE WORK CREWS IMMEDIATELY TO MAKE REPAIRS, INSTALL REPLACEMENTS, OR INSTALL ADDITIONAL CONTROLS AS NECESSARY.
- 8.7.2. REMOVE SEDIMENT FROM EROSION CONTROLS ONCE IT HAS REACHED 1/3 OF THE EXPOSED HEIGHT OF THE CONTROL.
- 8.8. THE CONTRACTOR WILL ENSURE THAT THE FOLLOWING MATERIALS FOR EMERGENCY EROSION CONTROL ARE ON-SITE.
- 8.8.1. A SUPPLY OF SEDIMENT CONTROL MATERIALS (I.E., SILT FENCE, STRAW BALES, BULK BAGS, ETC.)

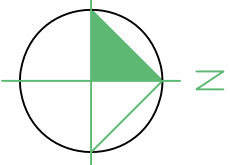

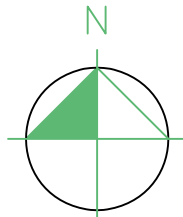

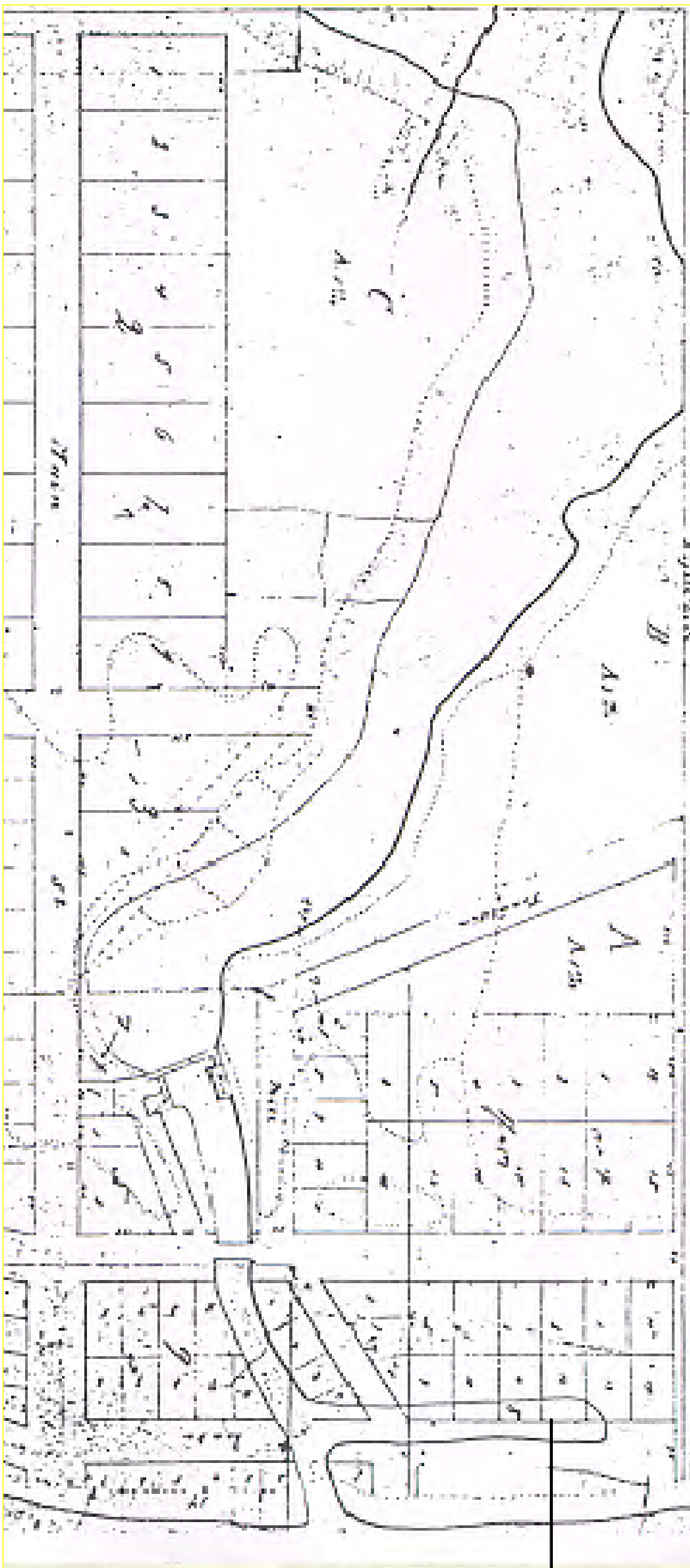

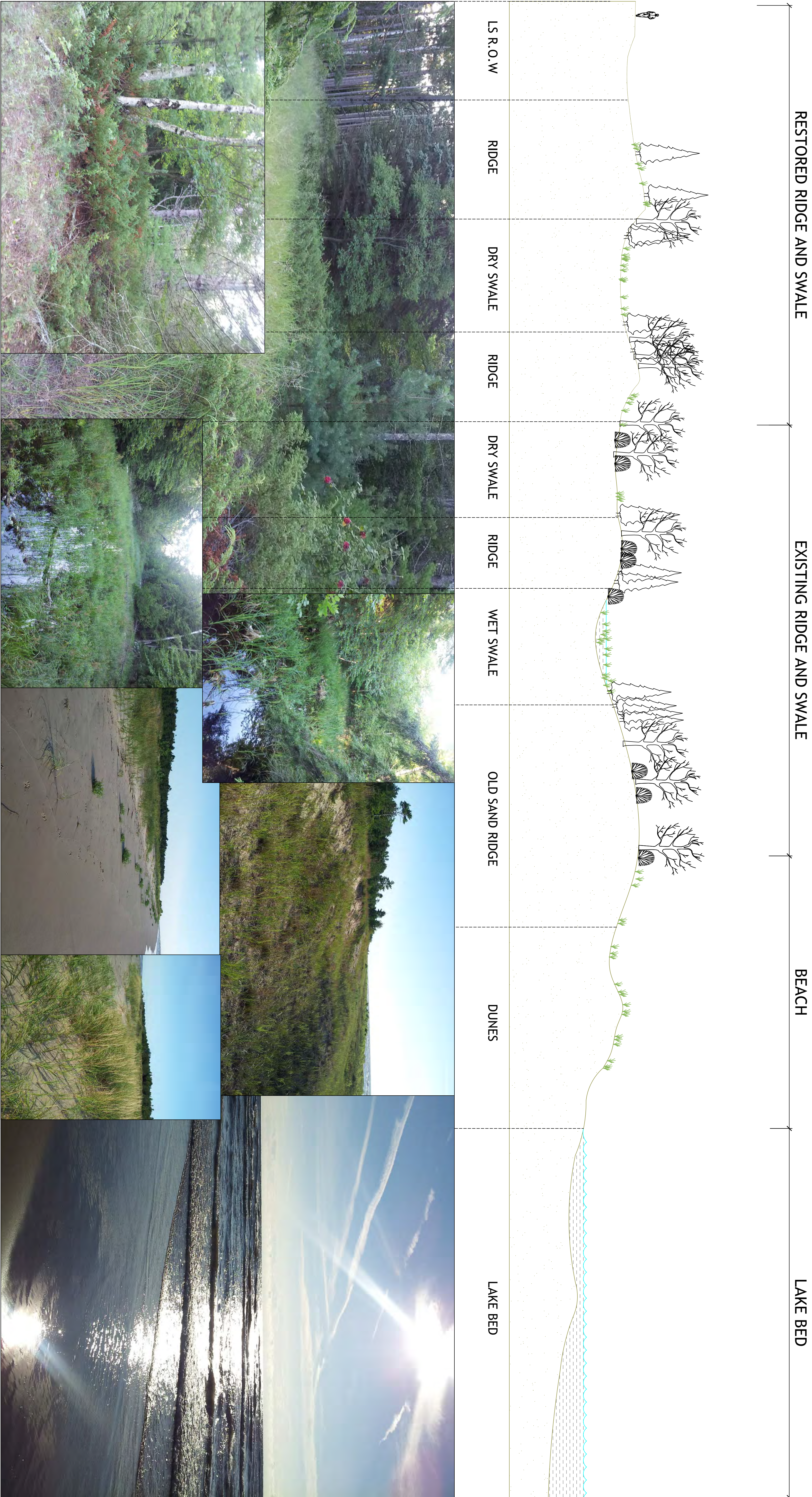
