ORDER APPROVING TRANSFER OF LICENSE

(Issued March 10, 2009)

By application filed January 21, 2009, NewPage Wisconsin System, Inc. (transferor) and Northbrook Wisconsin, LLC (Transferee) seek Commission approval to transfer the license for the Little Quinnesec Project No. 2536 from NewPage Wisconsin System, Inc. to Northbrook Wisconsin, LLC. The project is located on the Menominee River in Marinette County, Wisconsin.

Public notice of the transfer application was issued February 2, 2009, establishing March 4, 2009, as the deadline for filing comments, protests, and motions to intervene. The U.S. Fish and Wildlife Service filed a letter, stating it had no comments.

Transferee has agreed to accept all of the terms and conditions of the license and to be bound by the license as if it were the original licensee.

Transferor agrees to pay annual charges that have accrued to the date of the transfer. Transferee will be required to comply with the requirements of the license as though it were the original licensee. Transfer of the license for this project is consistent with the Commission's regulations and is in the public interest.

The Director orders:

(A) Transfer of the license for the Little Quinnesec Project No. 2536 from NewPage Wisconsin System, Inc. to Northbrook Wisconsin, LLC is approved.

(B) NewPage Wisconsin System, Inc. shall pay all annual charges that accrue up to the effective date of the transfer.

(C) Approval of the transfer is contingent upon: (1) transfer of title of the properties under license and delivery of all license instruments to Northbrook Wisconsin, LLC, which shall be subject to the terms and conditions of the license as though it were the original licensee; and (2) Northbrook Wisconsin, LLC, acknowledging acceptance of this order and its terms and conditions by signing and returning the attached acceptance

sheet. Within 60 days from the date of this order, the transferee shall submit certified copies of all instruments of conveyance and the signed acceptance sheet.

(D) This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 CFR §385.713.
