

Exotic Species for FERC Project # 1984-078

As per the order approving the Purple Loosestrife and Eurasian Water Milfoil Monitoring Plan for the Petenwell – Castle Rock Project (FERC Project # 1984 –078) issued on January 22, 2003, Wisconsin River Power Company (WRPCO) is submitting the survey for purple loosestrife.

Petenwell and Castle Rock Flowages were surveyed for purple loosestrife from July 29, 2004 through July 30, 2004. The presence of purple loosestrife was identified on the Petenwell Flowage, mainly on the north end. The results of the 2004 purple loosestrife survey on the Petenwell Flowage are similar to the results from the 2003 survey.

Purple loosestrife was identified in one area on the Castle Rock Flowage. The purple loosestrife identified was cut and sprayed using an approved herbicide. The results from the 2004 purple loosestrife survey for the Petenwell and Castle Rock Flowages are attached as Appendix A.

The schedule for Eurasian Water Milfoil is every three years, with the next survey scheduled to be conducted in 2006.

On October 1, 2004, the results of the surveys were sent to the U.S. Fish & Wildlife Service and the Wisconsin Department of Natural Resources. Documentation of submittal can be found under Appendix B (appendixes not included). At the time of this letter, neither agency has commented on the results.
