Water Quality Planning

Dane County Groundwater Protection Planning Framework (Appendix G)

• Work completed this contract period included releasing the report for public comment, meeting with representatives of the real estate community and their consultant regarding the report and revising sections of the report in response to public comments. This report has been finalized and adopted by the DNR as part of the *Dane County Water Quality Plan*.

Dane County Point Source Inventory and Analysis (Appendix C)

• Work completed this contract period included updating the draft report by incorporating comments from wastewater treatment plant staff and WDNR staff. This report has been finalized and adopted by the DNR as part of the *Dane County Water Quality Plan*.

Dane County Water Quality Summary Plan (2016-2017 Grant Funded Activity)

• Completed the first draft of this report to update the 2004 Summary Plan. Work on this report will carry-over into the next contract period. Remaining work includes releasing a draft for DNR and public comment, incorporating comments, and holding a public hearing for adoption.

Water Quality Plan Amendments

Sewer Service Area Amendments (2016-2017 Grant Funded Activity)

- Completed staff analysis reports and held public hearings for 5 amendments to the sewer service area boundaries of the *Dane County Water Ouality Plan*:
 - o Central Urban Service Area (Village of McFarland)
 - o Koshkonong Urban Service Area (Town of Albion)
 - o Sun Prairie Sewer Service Area
 - o Cottage Grove Sewer Service Area
 - o Northern Sewer Service Area (Village of DeForest)
- Worked with the multiple municipalities on their upcoming urban service area amendment proposals.
- Coordinated with DNR on the Water Quality Plan amendment process. Updated information packet and website to reflect the Water Quality Plan amendment process currently in place with DNR.

Environmental Corridor Amendments

- Completed staff analysis reports and held public hearings for 2 amendment to the Environmental Corridors boundaries of the *Dane County Water Quality Plan*:
 - o Central Urban Service Area (Village of McFarland)
 - o Sun Prairie Sewer Service Area.
- Worked with the Village of Waunakee on their upcoming amendment to the Environmental Corridors in the Waunakee Sewer Service Area.

Waubesa Wetlands Study Plan (2016-2017 Grant Funded Activity)

• Organized a steering committee, gathered background information, and conducted 6 steering committee meetings for the Waubesa Wetlands study plan. Prepared materials for these meetings including a draft work program and budget for the study.

- Prepared a consequence of failure GIS analysis for the Madison Metropolitan Sewerage District collection system
- Prepared a pumping station flow projection validity check for the Madison Metropolitan Sewerage District

- Reviewed plats and development plans for consistency with the environmental corridors adopted in the *Dane County Water Quality Plan*.
- Reviewed two MMSD annexations in the City of Verona for consistency with the *Dane County Water Quality Plan*.
- Reviewed the Mount Horeb wastewater treatment plant facilities plan for consistency with the *Dane County Water Quality Plan*.

Review of Fitchburg NEN Stormwater Monitoring (2016-2017 Grant Funded Activity)

- Met with the DNR, City of Fitchburg, and development team regarding the stormwater management plan for the Northeast Neighborhood.
- Completed a review of the stormwater management plan for the Terravessa plat in Fitchburg's Northeast Neighborhood.
