Environmentally Sensitive Area (ESA) Amendment Reviews

During 2017, Brown County Planning Commission staff reviewed nine ESA amendments, and began or completed work for a number of individuals and municipal representatives for various other ESA amendments for consistency with existing sewer service areas and elements of the areawide water quality management plan. The projects were at the following locations:

• Assisted the 24 municipalities with environmentally sensitive area inquiries related to the interpretation of the new 2040 Brown County Sewage Plan.

In addition, the Brown County Planning Commission staff performed the following:

- ESA 2017-01 (Minor Amendment) Revised ESA setback areas while maintaining no net loss of ESA acreage on site.
- ESA 2017-02 (Plan Correction) consisted of revising the FEMA floodway area based on an FEMA and WDNR approved flood study.
- ESA 2017-03 (Plan Correction) consisted of revising the steep slope area based on better/more accurate elevation data. There is no net loss of wetland with this project.
- ESA 2017-04 (Plan Correction) consisted of updating the ESA setback from FEMA floodway based on the updated 2009 FEMA data.
- ESA 2017-05 (Plan Correction) correction consisted of updating the ESA setback from FEMA floodway from 50' to the current standard of 35'.
- ESA 2017-06 (Minor Amendment) Revised ESA setback areas while maintaining no net loss of ESA acreage on site.
- ESA 2017-07 (Plan Correction) correction consisted of removing an ESA that was improperly shown on a combination CSM.
- ESA 2017-08 (Plan Correction) correction consisted of updating the boundary of a wetland based on a new (WDNR concurred) wetland delineation.
- ESA 2017-09 (Plan Correction) correction consisted of eliminating the ESA setback from the subject property due to more accurate measurements from the Ordinary High Water Mark (OHWM).
- ESA 2017-10 (Plan Correction) correction consisted of coordinating with WDNR staff and the property owner to expand a previous wetland scrape.
- ESA 2017-11 (Plan Correction) correction consisted of reducing the ESA setback in accordance with the Brown County Subdivision Code.
- ESA 2017-12 (Plan Correction) correction consisted of removing the ESA designation from a steep slope area and establishing the slopes as land unsuitable for development and establishment of a new ESA setback from the delineated wetlands.
