

Mark Renz will demonstrate two separate resources, the GLEDN (Great Lakes Early Detection Network) app and IPC-Connect (now called ISM Track). The GLEDN app allows for users to report invasive species observations via your smartphone or tablet. While it also has other resources (identification) the main function is to report the location and extent invaded by a specific species. The ISM Track resource (formerly IPC Connect) allows land managers to assign management information to those observations from a website. This management information can then be summarized into reports that will help track management of invasive species. So while both are useful resources that work together, the GLEDN app can be used independently from ISM-Track.

RE: Kayak launch at Lower Schuette Park

Dear Manitowoc Parks and Recreation Committee:

The Friends of the Manitowoc River Watershed (FMRW) formally adopted Lower Schuette Park in 2014 and installed an ADA compliance kayak launch in 2016. A formal dedication with a ribbon cutting occurred on June 22, 2016. The community-based group has also constructed "Leopold" style benches and a kayak rack for the park.

The Friends of the Manitowoc River Watershed (FMRW) and Lakeshore Natural Resource Partnership (LNRP) have been key partners involved in developing this kayak launch project. As part of adopting the park, FMRW performs monthly walkthroughs of the park, including the launch area, and notifies the City of any maintenance needed on the launch or other park amenities.

We are proposing to add an easily accessible approach to the kayak launch that would allow all users easy access from the parking lot over what is now a grassy area with a small depression. We have received an engineering design and a material list from Braun Building Center.

Total cost of the project is approximately \$17,500 that includes the designs, material list, labor, kayak rack, and benches. We are requesting \$8,271.86 from the City of Manitowoc's Parkland Dedication Fund for materials. LNRP has committed a 50% match to the project.

The mission of FMRW is to connect people to the Manitowoc River in order to increase awareness, appreciation and use of the river. The group developed the plan to increase river access through the creation of a Kayak/Canoe launch at Lower Schuette Park. We hope you will consider our proposal worthy of funding. We are ready to begin construction of the approach as soon as funding is secured.

In the winter of 2013, the Friends of the Manitowoc River Watershed (FMRW) adopted Lower Schuette Park in Manitowoc. The park is situated on 65 acres of land along the scenic Manitowoc River. Since the adoption, FMRW has worked hard to bring people back to this park, and continues to maintain, improve, and plan for future work in the park. This report is to update you as to the current state of the park.

As part of the Adopt-A-Park program, FMRW schedules monthly walk-throughs of the park. Reports are then submitted to the city to let them know about any major things that need to be addressed, but it also gives the city and FMRW gentle reminders of things that need to be done, or things that people would like to see done in the park. Those reports let us know when it is time to do some trail trimming, or if there is something obstructing a trail, if "doggy doo" bags are needed, or if vandalism has occurred. This summer was the first time there was a "Port-A-Potty" made available to the park, so our friendly walk-through volunteers kept an eye on that for us as well. Volunteers also often pick up trash while walking through the park.

In the spring of 2016, an ADA compliant kayak launch was installed in Lower Schuette Park, giving our city a place to have organized paddles and a great place to host events that bring people to the park. A bench and kayak rack have also been donated to the park by FMRW, as well as garbage and recycling receptacles. The spring of 2017 brought the addition of a boardwalk that makes for easy access to the launch from the parking lot. A railing is in the process of being added to the boardwalk. We have had a ribbon cutting ceremony for the kayak launch, and the local television show "Discover Wisconsin" came down to the park and the kayak launch this summer to film a segment about paddling opportunities in Manitowoc County.

A wish list has been made for the park, and many things have already been accomplished. The stairs within the park have been a huge concern for a long time, and this summer, there were repairs made to some of the areas that needed it most. Benches that needed painting have been painted. Potholes and ruts in the trails continue to be filled. Lighting has long been a safety issue in the parking lot, and last month, large light posts were added. FMRW has worked with the city to allocate funds for future projects, like trail mapping and informative signage for the trails. There are plans to start addressing areas of the park where invasive species are an issue with "Project Red", which is a program that provides training to recognize and learn about invasive species that are of local concern and make plans for eradication. It is a great program that will improve the health of the park

Overall, I think the state of the park is well on its way to great. We will continue to identify key issues and challenges facing the park and work to address them. We will also continue to provide stewardship activities and set and accomplish goals to maintain and improve the park.

Manitowoc County Volunteer Group Plans River Clean-up June 4

Manitowoc, Wis. -- The Friends of the Manitowoc River Watershed invites area citizens to join them Saturday, June 4, to help clean up litter and other debris in the Manitowoc River.

Participants will meet at Lower Schuette Park in Manitowoc at 9:00 a.m. with their own canoes or kayaks. They will provide all cleaning supplies needed.

Group co-founder Kim Kettner said, "For those who don't want to paddle, we also need people to walk along the shoreline at Schuette Parks to collect litter. Please join us to help make a difference in the beauty and health of our adopted City park and the Manitowoc River."

They organize two beach clean ups in the spring and fall each year along with a river clean up. To date, they have removed several tons of garbage from Manitowoc's beaches and the Manitowoc River.

The group adopted Lower Schuette Park two years ago and added a kayak launch last fall with help from the City of Manitowoc. A ribbon-cutting dedication ceremony is being planned for June 22 so watch for details. For more information, contact Kim at 920-242-1993.

The real story is the person who found the sofa is handicapped and was using our new launch for the first time. He was able to help us in this event a whole lot easier with the new launch. He still needed some assistance because we don't have the approach assembled yet.

At the Wisconsin Maritime Museum for brief intro of new camp friends and the projects being done this year; city bus to the Manitowoc Rapids area for storm drain stenciling service project); then out to Collins Marsh for the afternoon: Manitowoc River Watershed, canoeing on the marsh, view from the tower, water testing, fish sampling and identification.

Tuesday, August 2:

Start at WMM for overview and review; then walk to Warm Waters for beach cleanup; visit the Little Manitowoc River for water testing, invasive species identification, minnow traps; lunch, then tobacco/beach exhibit set up in the Wisconsin Maritime Museum and project prep. Wednesday, August 3:

Start at WMM for review and overview; bus to Michael J. Dodge Nature Preserve on the Branch River north of Whitelaw; river study, invasive plant species, water testing, habitat study, crayfish study, lunch then kayak the Manitowoc River

Thursday, August 4: PLEASE NOTE WE NEED ALL TO ARRIVE AT 8:00 today for earlier departure to Milwaukee! Bus to Milwaukee School of Freshwater Sciences to learn about what water scientists are working on right now; lunch (students should bring money for lunch); then back to Manitowoc for fishing, swimming, project prep in the afternoon.

Friday, August 5:

Final project completion time with their groups; lunch; then cruise on the Skyline Princess on the Manitowoc River and Lake Michigan to do water testing.

Camp project:

The campers will be split into three groups and each group will be working on a project. The three topics for the projects are: beach data (litter), water science topics from School of Freshwater Science, and applying ROVs to Great Lakes issues.

For each activity that we do, the campers will need to come up with an investigative question that they can then answer. This question can be one that applies to their project topic or one that intrigues them. They will be held accountable to answering these questions. They can share their questions with other groups if it helps with their projects!

This past summer, the Wisconsin Maritime Museum had 14 kids partake in the Watershed Ambassador's Camp. This was an all-day week-long camp. Every day was spent doing different activities to help the students learn and engage with the Manitowoc River Watershed. A wish list has been made for the park, and many things have already been accomplished. The stairs within the park have been a huge concern for a long time, and this summer, there were repairs made to some of the areas that needed it most. Benches that needed painting have been painted. Potholes and ruts in the trails continue to be filled. Lighting has long been a safety issue in the parking lot, and last month, large light posts were added. FMRW has worked with the city to allocate funds for future projects, like trail mapping and informative signage for the trails. There are plans to start addressing areas of the park where invasive species are an issue with "Project Red", which is a program that provides training to recognize and learn about invasive species that are of local concern and make plans for eradication. It is a great program that will improve the health of the park

Overall, I think the state of the park is well on its way to great. We will continue to identify key issues and challenges facing the park and work to address them. We will also continue to provide stewardship activities and set and accomplish goals to maintain and improve the park.
