

2017 DASH SUMMARY Deer Lake, Lincoln County, WI

Diver Assisted Suction Harvesting (DASH) of Eurasian Water Milfoil (EWM) took place on July 16th, 17th and 18th, 2017 on Deer Lake, Lincoln County, Wisconsin. **(Figure 1)**. A survey performed on June 7, 2017 by Onterra LLC confirmed the locations of EWM and 3.99 acres at 7 separate areas were targeted for harvest. Conditions during the survey were excellent with full sun and low winds.

July 16, 2017

Areas C-17 and D-17 were harvested using the DASH barge with one diver on hookah air supply and another person on the barge collecting the material in mesh bags. The wind was at 7mph, waves were calm, air temp was 68 degrees working at a depth of 10 feet.

Area C-17: 4.5 hours with a total of 158 lbs of material harvested (approx. 5% non-target plants)

Area D-17: 3.5 hours with a total of 264 lbs of material harvested (approx. 5% non-target plants)

July 17, 2017

Areas D-17 and F-17 were harvested using the DASH barge with one diver on hookah air supply and another person on the barge collecting the material in mesh bags. The wind was 7 mph, waves were calm, air temp was 55 degrees working at a depth of 10 feet.

D-17: 3hours 10min with a total of 159 lbs of material harvested (approx. 5% non-target plants)

F-17: 4 hours with a total of 169 lbs of material harvested (approx. 5% non-target plants)

July 18, 2017

Areas E-17 and G-17 were harvested using the DASH barge with one diver on hookah air supply and another person on the barge collecting the material in mesh bags. The wind was 5 mph, waves were calm, air temp was 70 degrees working at a depth of 9 feet.

E-17: 5 hours 15 mins with a total of 246 lbs of material harvested (approx. 5% non-target plants)

G-17: 1 hour 30 min with a total of 36 lbs of material harvested (approx. 5% non-target plants)

Table 1 shows the acreage, lbs harvested, time spent and lbs per hour.
