The amendment, which was requested by the City of Fitchburg, adds 9.65 acres to the Central Urban Service Area in order to provide sewer service to a proposed elementary school to be built by the Verona Area School District.



SUBJECT: City of Fitchburg sewer service area amendment.

Dear Mr. Lane:

We have reviewed the City of Fitchburg's sewer service area amendment for the proposed Verona Area School District - elementary school and we approve their request. The 9.65 acre amendment is part of a greater site already within the central urban service area and it has no significant environmentally sensitive features. Please see the attached map.

The Dane County Planning Commission's approving resolution (No. 732) includes a condition stipulating that the City's stormwater management requirements emphasize water infiltration.

The approval of this revision does not constitute approval of any of the following:

- private sewage systems pursuant to Chapter ILHR 83, 0
- sewer extension pursuant to Chapter NR 110, (WI Admin. Code),
- authority to alter the bed or banks of any navigable waterway (Chapter 30, WI O Stats.), or
- certification for any wetland alteration (Section 401, Federal Water Pollution O Control Act, and NR 103, 299, WI Admin. Code).

Those approvals must be obtained separately from the respective agencies.

Any person aggrieved by this approval has the right to appeal the decision. Wisconsin Statutes and Administrative Code establish time periods within which requests to



review Department decisions must be filed. For judicial review of a decision pursuant to s. 227.52 and 227.53, Wis. Stats., a petition for review must be filed within 30 days after service of the decision. The respondent in an action for judicial review is the Department of Natural Resources. This notice is provided pursuant to s. 227.48(20), Wis. Stats.
