SUBJECT: Central Urban Service Area (CUSA) Amendment – City of Fitchburg

Dear Mr. Lane:

The Department of Natural Resources has completed the review of, and approves, the amendment to the Dane County Water Quality Plan revising the CUSA for the City of Fitchburg. The amendment adds 41 acres to the CUSA, including 22.6 acres of environmental corridors, 13.3 acres of existing development, for a net developable area of 5.1 acres (see attached map). The amendment area is located south of Lacy Road in the Dommers View area and includes a combination of an existing 18 lot residential development, a portion of a city park (McGaw) and 14 planned residential lots. The amendment area would accommodate a total of 32 housing units for a potential population of 85.

The approval of this amended sewer service area plan does not constitute approval of any of the following:

- private sewage systems pursuant to Chapter COM 83 (WI Admin. Code)
- sewer extension pursuant to Chapter NR 110 (WI Admin. Code)
- authority to alter the bed or banks of any navigable waterway (Chapter 30, WI Stats.)
- certification for any wetland alteration (Section 401, Federal Water Pollution Control Act, and NR 103, 299, WI Admin. Code)
- takings of threatened and endangered resources pursuant to Wisconsin Statutes 29.415.

Those approvals must be obtained separately from the respective agencies. In addition, stormwater management plan development is required for any construction site activity disturbing five or more acres of land pursuant to Chapter NR 216 (Wis. Admin. Code).

Any person aggrieved by this approval has the right to appeal the decision. Wisconsin Statutes and Administrative Code establish time periods within which requests to review



Department decisions must be filed. For judicial review of a decision pursuant to s. 227.52 and 227.53, Wisconsin Statutes, a petition for review must be filed within 30 days after service of the decision. The respondent in an action for judicial review is the Department of Natural Resources.
