Dear Mr. Steinhoff:

We have completed our review and approve of the Waunakee sewer service area amendment request submitted to the DNR on June 15, 2018 (Water Quality Management Letter No. 1801). The Waunakee amendment brings 5794 Emerald Grove Lane to the Waunakee Urban Service Area. CARPC staff analysis is attached. CARPC Waunakee SSA Amendment 2018 - Staff Analysis. The Village of Waunakee supports this amendment and it is in compliance with the facilities plan and AWQM Plan.

This amendment is a formal update to the state's Areawide Water Quality Management Plan and the Dane County WQM Plan and will be sent to the US Environmental Protection Agency to meet the requirements of the Clean Water Act of 1987 (Public Law 92-500 as amended by Public Law 95-217) and outlined in the federal regulations 40 CFR, Part 35. This review is an integrated analysis action under s. NR 150.20 (2) (a) 3, Wis. Adm. Code. This review fulfills ch. NR 150, Wis. Adm. Code, and with s. 1.11, Stats. The approval of this amendment does not constitute approval of any other required local, state, or federal permit for sewer construction or associated land development activities.

Appeal Rights:

Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions must be filed. For judicial review of a decision pursuant to sections 227.52 and 227.53, Wis. Stats., a party has 30 days after the decision is mailed, or otherwise served by the Department, to file a petition with the appropriate circuit court and serve the petition on the Department. Such a petition for judicial review must name the Department of Natural Resources as the respondent.

To request a contested case hearing pursuant to section 227.42, Wis. Stats., a party has 30 days after the decision is mailed, or otherwise served by the Department, to serve a petition for hearing on the Secretary of the Department of Natural Resources. All requests for contested case hearings must be made in accordance with section NR 2.05(5), Wis. Adm. Code, and served on the Secretary in accordance with section NR 2.03, Wis. Adm. Code. The filing of a request for a contested case hearing does not extend the 30-day period for filing a petition for judicial review.
