- Those seeking to sit for the **Level 1 (i.e., In-Training)** examination do not submit any application material BUT must register for the training modules.
- Existing **CISEC-IT** registrants seeking to sit for the **Level 2** examination must complete the following:
  - Submit a completed application form on their qualifications.
  - Provide documentation that they conducted sediment and erosion control and/or storm water inspections under the supervision of an experienced inspector mentor (please provide names and phone numbers) to accumulate the necessary 2-years of inspection experience.
  - Receive written permission from CISEC, Inc. to sit for the test.
- Those seeking to sit for the **Level 3** examination **MUST** complete the following:
  - Submit a completed application form on their qualifications.
  - Receive written permission from CISEC, Inc. to sit for the test.

**CODE OF ETHICS**  
**Certified Inspector of Sediment and Erosion Control**

**Article I. General Principles**

1. The privilege of professional practice imposes obligations of morality and responsibility as well as professional knowledge.
2. Each Certified Inspector of Sediment and Erosion Control (hereafter called CISEC) agrees to be guided by the highest standards of ethics, personal honor, and professional conduct.

**Article II. Relation of Professional to the Public**

1. A CISEC shall not give a professional opinion or make a recommendation without being as thoroughly informed as might reasonably be expected of a similarly situated professional.
2. A CISEC shall not knowingly permit the use of his or her reports or other documents for any unsound or illegitimate undertaking.
3. A CISEC shall not issue a false statement or false information at any time.
4. A CISEC shall not make any sensational, exaggerated, and/or unwarranted statements in any professional opinion or in the course of performing any professional services.
5. A CISEC may publish dignified business, professional, or announcement cards, but shall not advertise his or her work or accomplishments in a self-laudatory, exaggerated, or unduly conspicuous manner.

**Article III. Relation of Professional to Employer and Client**

1. A CISEC shall not use, directly or indirectly, any employer or client's information in any way that would violate the confidence of the employer or client.
2. A CISEC shall protect, to the fullest extent possible, the interest of their employer or client insofar as such interest is consistent with the law and his or her professional obligations and ethics.

3. A CISEC shall not accept compensation, directly or indirectly, for recommending contractors, services, or products to inspection clients or other parties having an interest in inspected properties.

## Runoff & Municipal Storm Sewer Systems

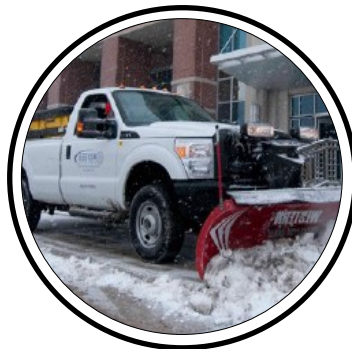

## Chloride & Abrasives Pollution

- Once applied, snow and ice melting compounds become a permanent pollutant. They pollute nearby soils and, when dissolved in water through runoff or infiltration, contaminate surface and ground water resources.
- Sand and other abrasives end up in storm drains and cause sedimentation of stormwater ponds, lakes and rivers.
- Excess salt in soils causes:
  - vegetation die offs
  - soil erosion
  - soil compaction

## Best Management Practices (At a Glance)

- Store snow away from stormdrains, ditches, ponds, creeks, and wetlands
- Store salt and sands indoors on an impervious surface
- Utilize proper equipment and inspect to ensure it is functioning as expected
- Remove snow early and often to reduce the amount of compaction and need for ice removal
- Understand the products you are using:
  - **sand** provides traction—it does not melt ice
  - **salt**—only effective when the air temperature is warmer than the pavement temperature. A little goes a long way under the right conditions. Follow manufacturer application rates.

## Planning

- Create a list of actions to take before, during and after winter precipitation
- Tailor plans for specific locations
- Follow the plan, document actions taken and review/update the plan as needed.

## Before Applying Salt or Sand... know this!

- **Monitor the weather:** Know and understand the current weather pattern and temperatures as this will affect the type and rate of materials application.
- **Surface Temperature:** The temperature of the surface can be different than the air temperature. Knowing this helps determine types and rates of material application.
- **Anti-Icing:** Utilize anti-icing strategies (liquids) prior to winter precipitation to prevent snow & ice bonding to the surface.

## Salt or De-Icer Application (sidewalk tips)



- Hand-apply deicer or sidewalk salt. Do not use more than needed, apply to manufacturer's recommendations.
- Drop spreaders keep materials from spreading onto adjacent

landscaping

- Manually removing snow aggressively will reduce the amount of deicer needed.
- Proper application (3in between granules) will effectively do the job

## Using the Right Equipment

- Use pavement sensors to test the surface temperature
- Use equipment that can be adjusted for lower application rates
- Outfit vehicles with ground speed controls to allow application rates based on vehicle speeds
- Properly calibrate applicators to manufacturer's recommendations based on materials to be applied



## Snow, Sand, & Salt Storage

- Never plow, push, blow or store excess snow, deicer, or other debris into creeks, watercourses or storm drainage systems. Snow storage areas should be located away from ditches, ponds, creeks or wetlands. If possible, areas should be self-contained and internally drained.
- Store excess snow in an area where solids can be recovered after snowmelt.
- Store excess salt and sand indoors on an impervious surface

**Getting started early, developing a plan and applying Best Management Practices to Winter Parking Lot & Sidewalk Maintenance activities can save money by lowering materials, personnel and other costs!**

## Using the Right Materials



*De-icing substances (whether solid or liquid) have different properties.*

### Chlorides:

- Sodium Chloride (Road Salt)
  - Ineffective below 15°
- Calcium Chloride
  - Ineffective below -20°
- Magnesium Chloride (liquid)
  - Ineffective below -10°
- Potassium Chloride

### Sand (Traction Control)

- Use when temperatures are too cold for de-icing chemicals

## Anti-Icing Facts

- Use a salt brine before the storm to prevent snow & ice from bonding to surfaces
- Can be effective for several days depending on weather conditions
- Cost-effective & Safer on the environment
- Requires about 25% of material
- 10% of de-icing cost



## Northeast Wisconsin Stormwater Consortium (NEWSC)

### Stormwater BMP Trainings/Workshops - Workplan



Amendment Date: 6/1/19

#### HISTORY

Since 2016, the Northeast Wisconsin Stormwater Consortium has held two separate workshops, focused on stormwater structure best management practices (BMP's). In 2016, a planning committee was formed and a workshop was planned for education of stormwater pond maintenance and inspection. Approximately 38 persons, mostly municipal employees, attended this workshop. Another planning committee was formed in 2017 and a Stormwater Pond Vegetation Management and Maintenance workshop was held in November. Day 1 of this two-day workshop was focused on the management set up for newly planned stormwater ponds or stormwater pond redevelopment construction sites. Day 1 attendance total was 19 individual and were mostly municipal employees in management, decision making or recommending to decision makers positions. Day 2 of the two-day workshop focused on stormwater pond vegetation maintenance with identification of beneficial and invasive plant species and proper maintenance of vegetation in and around stormwater ponds. Attendance for this day of the workshop included 27 persons, mostly municipal employees tasked with stormwater pond maintenance duties or management of employees with those duties. The planning committee from 2017 reconvened in 2018 and has planned a Stormwater Pond Vegetation Management and Maintenance Field Day as a follow up for the 2017 workshop. Invitations have been sent to those that attended the 2017 workshop. The agenda for the field day includes a recap of key components from the 2017 workshop and "hands on" learning of plant identification and vegetation maintenance techniques. The Northeast Wisconsin Stormwater Consortium's Municipal Committee is currently in the planning stages for a new workshop that will occur in quarter 4 of 2018 with a focus on Filtration Systems (biofilters, etc).

In 2016, NEWSC identified a need to come up with a plan for providing additional stormwater BMP trainings. In order to provide additional funding for future trainings in 2017 while also providing a mechanism for planning future trainings, Fox-Wolf Watershed Alliance staff submitted a Wisconsin Department of Natural Resource River Planning Grant which included a workplan and deliverables focused on Stormwater BMP workshops, trainings, education materials and planning efforts. The deliverables of the approved grant, as they relate to Stormwater BMP education, include the following:

1. **Development of a 3 to 5 year planning document providing the framework for development and delivery of educational materials regarding stormwater control structures.**
2. Creation of a database of stormwater structure owners (public and private) in order to identify potential workshop attendees.
3. Development and distribution of educational materials.
4. Provide other educational opportunities through workshops or trainings.



In an effort to identify the needs of the NEWSC membership, relating to stormwater BMP workshops and trainings, a survey was conducted at a full membership meeting. The November 13, 2017 meeting was attended by 27 persons representing 16 municipalities and 6 private businesses. The survey identified five potential training topics. The survey results ranked these potential topics (#1 receiving the most votes, #5 receiving the least votes)

1. Bio-filtration Systems
2. Emerging/New Technologies
3. Stream Restorations for P reductions
4. “Advanced” Stormwater Pond Systems
5. Wetland Restorations

At another NEWSC membership meeting on May 14, 2018, breakout discussions were planned in order to further identify specific needs for stormwater BMP education, trainings and workshops. This meeting was attended by 28 individuals representing 14 municipalities, 8 businesses and the Wisconsin Department of Natural Resources. Two rounds of breakout discussions, each lasting approximately 15 minutes, were held. The breakout discussions, as they relate to this planning document, included:

- 2018 Bio-filtration Systems education: Needs analysis
- Future Stormwater BMP education: Needs analysis

The Northeast Wisconsin Stormwater Consortium’s Municipal Committee held a meeting on June 5, 2018. At this meeting, the committee presented the findings from the full membership meeting breakout discussions and formulated a plan for providing educational opportunities on stormwater control structures in Northeast Wisconsin.

It should be noted that the Northeast Wisconsin Stormwater Consortium is a collaborative membership of municipalities and businesses located in northeast Wisconsin with a focus on Municipal Separate Storm Sewer System permitting. The consortium is guided by an elected Leadership Council and has four additional committees:

- General Public Committee
- Municipal Committee
- Building & Development Committee
- Stormwater Quality Management Committee

The Leadership Council and Committees meet approximately once per quarter and additionally, as-needed. Full membership meetings occur bi-annually, typically in November and May.

The developmental history of this plan does not include additional and other discussions that occurred regarding this planning process at the various committee or council meetings that have occurred.



#### OVERALL EDUCATIONAL OPPORTUNITIES PLAN

This planning document will list stormwater structure best management practice educational needs based on information collected within the past 18 months. The plan addresses previous educational opportunities that have occurred, opportunities currently being planned and additional future needs.

The Northeast Wisconsin Stormwater Consortium has held two previous workshops, one in 2016 and another in 2017 that are included in the plan. It is hoped that once agendas and materials have been developed for future workshops, the organization can begin offering these workshops on a rotating basis, either yearly, bi-annual or quarterly. Additionally, in the future, NEWSC may explore additional methods of providing the educational opportunities outlined herein such as a video presentation.

NEWSC has identified the following workshop topic needs and will offer educational workshops, trainings and materials for these topics:
