Activities completed/work accomplished this quarter:

- 1854 Treaty Authority completed 2019 wild rice monitoring in the estuary.

- Fond du Lac Natural Resources completed wild rice seeding; seeding 47.4 acres at 11 sites in Wisconsin waters.
- St. Louis River Alliance completed 4 weeks active goose deterrence, supplemental wild rice seeding at Clough Island and 2 volunteer workdays. Initial drafts were completed for the tribal oriented interpretive display and kiosk signage.
- -Peterson continued coordination/management meetings including: 3 meetings with SLRA regarding the kiosk project, the full partnership seeding coordination meeting and met to update MPCA AOC Coordinator on seeding and outreach efforts.

Schedule:

Is the project on track for completion by end date? A schedule of tasks has been developed for the revised Dec 31, 2019 project end date. Project is on schedule to complete the tasks as outlined.

Grant End Date:

Revised end date December 31, 2019 (Amendment #3 April 23, 2019). December 31, 2018 (Original contract dated 11/2/2016, Amendment #1 dated 8/15/2017, Amendment #2 dated 10/16/2018).

Problems / Issues:

Wild rice seed production throughout the region was moderate this year. Fond du Lac NR was only able to acquire about 75% of the planned amount of wild rice.

Fond du Lac Natural Resources used a variable rate seeding strategy in response to differing germination success and goose grazing pressure at project sites. Fond du Lac seeded 47.4 acres at 11 sites using a total of 5012 lbs of seed. Seeding rates varied from 24 lbs/ac to 314 lbs/ac. A more complete description will be included in the annual report.

A lot of work was performed by sub-contractors this quarter. However, MLT had not received invoices, or made payments for that work by the end of the quarter.
