State of Wisconsin Town of Scott Burnett County Ordinance No. O2020-03

SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Town of Scott Boat Launch Ordinance. The purpose of this ordinance is to authorize the Town Board of the Town of Scott, or it's designees, to issue citations for violations of Town of Scott ordinances, including ordinances with statutory counterparts.

SECTION II - AUTHORITY

The Town Board of the Town of Scott, Burnett County, Wisconsin, has the specific authority under s. 66.0113, Wis. Stats., to adopt this ordinance.

SECTION III - ADOPTION OF ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides the authority for the town, or it's designees, to issue citations for violations of Town of Scott ordinances, including ordinance with statutory counterparts.

SECTION IV - SUBDIVISION AND NUMBERING OF THIS ORDINANCE

This ordinance is divided into sections designated by uppercase Roman numerals. Sections may be divided into subsections designated by uppercase letters. Subsections may be divided into paragraphs designated by numbers. Paragraphs may be divided into subdivisions designated by lowercase letters. Subdivision may be divided into subdivision paragraphs designated by lowercase Roman numerals. Reference to a "section", "subsection", "paragraph" or "subdivision" includes all divisions of the referenced section, subsection, paragraph or subdivision.

SECTION V - DEFINITIONS

A. A "boat launch" is defined as a Town of Scott boat launch that has been properly designated as being open to launch a boat and that specified launch is owned by the Town of Scott.

B. Town of Scott boat launches are identified in Attached Article A.

SECTION VI - ENFORCEMENT

This ordinance may be enforced by any law enforcement officer authorized to enforce the laws of the State of Wisconsin. (and additionally as stated in the Town's citation authority oridnance adopted per s. 66.0113 Wis. Stats.)

SECTION VII - PENALTIES

The penalties for violation of this ordinance are set forth under s. 23.33(13)(a) Wis. Stats. And are adopted by reference.

SECTION VIII - SEVERABILITY

If any provision of this ordinance or it's application to any person or circumstance is held invalid, the invalidity does not effect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to that end the provision of this ordinance are severable.

SECTION IV - SUPERSEDES PRIOR ORDINANCES OR REFERENDUM

This ordinance supersedes any prior Town of Scott ordinance or referendum relating to boat launches.

SECTION X - EFFECTIVE DATE

This ordinance is effective on publication or posting. The Town clerk shall properly publish this ordinance as required under s. 60.80. Wis. Stats.
