Environmentally Sensitive Area (ESA) Amendment Reviews

During 2020, Brown County Planning Commission staff reviewed 7 ESA amendments, and began or completed work for a number of individuals and municipal representatives for various other ESA amendments for consistency with existing sewer service areas and elements of the areawide water quality management plan. The projects were at the following locations:

- Assisted the 24 municipalities with environmentally sensitive area inquiries related to the interpretation of the new 2040 Brown County Sewage Plan.
- Miscellaneous items documented under "Technical Assistance, Information, and Education."

In addition, the Brown County Planning Commission staff performed the following:

- 2020-01 (HOW) Plan Correction This plan correction removed a wetland identified on 62CSM98 due to a state wetland exemption determination.
- 2020-02 (SCO) Plan Correction This plan correction reduced a setback to a navigable waterway from 100' to the current setback of 75'.
- 2020-03 (HOW) Plan Correction This plan correction reduced a wetland setback from 50' to the current setback of 35'.
- 2020-04 (LAW) Plan Correction This plan correction revised the 20' setback from a steep slope ESA based on more accurate elevation data.
- 2020-05 (LAW) Plan Correction This plan correction sought to reduce the floodway setback however wetlands were present, and a wetland delineation was required to ensure all ESA's were identified on site and appropriate setbacks were identified and maintained.
- 2020-06 (HOW) Minor This minor amendment sought to amend the ESA setback due to disturbance of a hillside by a previous property owner. This total amount of ESA acreage was maintained on site.
- 2020-07 (LAW) Minor This minor amendment sought to reduce an ESA setback from 35' to 15' to allow for a single-family residence to be constructed on site. No other buildable area was available on site and the total ESA acreage was maintained.
