RE: Amendment to Fox West Sewer Service Area for School Road Transport Sewer

Dear Wilhelmina:

The Village of Greenville Utility Department is requesting an amendment to the current Fox West Sewer Service Area. The location that the Utility is requesting to be amended is 1320 LF of 8" PVC sewer located on the north side of School Road. The amended area commences 410' west of the intersection of School Road and Churchill Road and extends 910' east of the same intersection. This results in a total length of 1,320' and an area of 87,120 Sq Ft.

This sewer line is being constructed as part of road reconstruction project. There are existing homes that will be connected to the sewer line but no new homes will be serviced by this sewer line. This sewer line and the amended area will connect two existing locations within the existing Fox West Sewer Service Area. As a result, this amendment serves as an extension adjacent to the existing Fox West Sewer Service Area and will not service any new developments.

The Utility Department understands that any new development of the adjacent lands with sanitary connections will require a separate amendment to the Fox Cities Sewer Service Area Plan.
