Ordinance #L

AN ORDINANCE TO REGULATE WATER TRAFFIC, BOATING AND WATER SPORTS UPON THE WATERS OF STONE LAKE, WASHBURN COUNTY, WISCONSIN AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

The Town Board of the Town of Stone Lake, County of Washburn, Wisconsin do ordain as follows.

Section 1. APPLICABILITY AND ENFORCEMENT. The provisions of this ordinance shall apply to the waters of Stone Lake, within the jurisdiction of the Town of Stone Lake, County of Washburn, Wisconsin, which waters are discribed as follows.

The entire portion of Stone Lake. The provisions of this ordinance shall be enforced by the law inforcement officers of the Town of Stone Lake, along with all other State and County officers authorized by law to enforce the same.

Section 2. SPEED RESTRICTIONS AND REGULATIONS. No person shall operate a motor boat at a speed greater than is resonable and prudent under the conditions and having regard for the actual and potential hazards that exist. Speed of a motor boat shall be so controlled as to avoid colliding with any other conveyance in or on the water in compliance with legal requirements, and exercising due care.

Section 3. WATER SKIING. Prohibiting certain times and exceptions.
a) Except as provided in paragraph (b) no person shall operate a motor boat, towing a person on water skies, aquaplane or similar device, nor shall any person engage in water skiing, aquaplaning or similar activity at any time before 10:00 o'clock in the morning of each day and after 7:00 o'clock in the evening of each day in June, July and August.
b) Paragraph (a) does not apply to duly authorized water ski tournaments, competitions, exhibitions or trails therefor where adequate lighting is provided and where the permission to stage such tournaments, competitions or exhibitions has been received from the Town of Stone Lake, County of Washburn, Wisconsin.
c) No person shall operate a boat for the purpose of towing a person on water skies, aquaplane or similar device or permit himself to be towed for such purpose, unless there is in the boat a competent person in addition to the operator, in a position to observe the activity of the person being towed. The observer must be competent in fast and must observe the person being towed and relay signals to the operator.

Section 4. LITTERING WATERS PROHIBITED. No person shall deposit, place or throw from any boat, raft, pier, platform or similar structure, any cans, papers, bottles, debries, refuse, garbage, solid or liquid waste in the waters of Stone Lake.

Section 5. PENALTIES. Wis. Statues 30.80, sub (1),(2),(3),&(4) will apply to all violations of this ordinance and violations of S.S. 30.50 to 30.80.

Section 6. Except as herein above specifically provided, the Town of Stone Lake hereby adopts along with this ordinance and incorporates the same herein by reference all of the provisions of section 30.50 to 30.80 inclusive of the revised statutes of the State of Wisconsin.

This ordince shall be full force and effect on and after 31 day of may 19 89
