#### CHAPTER 13: PUBLIC WATER ORDINANCES

#### 13.0100 INTRODUCTION

Slow No Wake Hours. A sole ordinance to regulate boating upon the water of Lake Mary and prescribing penalties for violation thereof. The Town Board of the Town of Wagner does ordain as follows:

## 13.0200 APPLICABILITY AND ENFORCEMENT

The provisions of this ordinance shall apply to the waters of Lake Mary. This chapter shall be enforced by the officers of the County of Marinette Sheriff Department.

#### 13.0300 INTENT

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests and the capability of the water resources.

#### 13.0400 STATE BOATING AND SAFETY LAWS ADOPTED

State boating laws as found in ss. 30.50 to 30.71, Wis. Stats., are adopted by reference here.

#### **13.0500 PENALTIES**

Wisconsin State boating penalties as found in s. 30.80, Wis. Stats., and deposits established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conferences, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment are deleted.

#### 13.0600 SEVERABILITY

The provisions of this ordinance shall be deemed severable, and it is expressly declared that the Town of Wagner Board would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

### **13.0700 DEFINITION**

"Slow-No-Wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.

#### 13.0800 SLOW NO WAKE HOURS OF OPERATION

No person shall operate a boat faster than slow-no-wake during the hours of 4:00PM to 10:00AM local time in the waters of Lake Mary.

## 13.0900 POSTING REQUIREMENTS

The Town of Wagner shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town of Wagner, Marinette County pursuant to the requirements of NR 5.15, Wis. Adm. Code.

## 13.1000 EFFECTIVE DATE

The foregoing ordinance is hereby adopted by the Town Board of the Town of Wagner on this  $12^{th}$  day of April 2022 and shall take effect upon publication.
