§ 204-1. State boating laws adopted. ¹

The statutory provisions describing and defining regulations with respect to water traffic, boats, boating and related water activities in the following enumerated sections of the Wisconsin Statutes and in the rules and regulations of the Wisconsin Department of Natural Resources established pursuant to said statutory sections, now existing or established subsequent to the enactment of this chapter, exclusive of any provisions therein relating to the penalties to be imposed or the punishment for violation of said statutes, rules and regulations, are hereby adopted and by reference made a part of this chapter as if fully set forth herein. Any act required to be performed or prohibited by the provisions of said statutes, rules or regulations incorporated by reference herein is required or prohibited on waters within the Village by this chapter.

§ 204-2. Use of motorized vessels or vehicles prohibited. [Amended by Ord. No. 2-97; Ord. No. 39-89]

- A. No person may operate, occupy or use a motorized vehicle or vessel of any type on Springville Pond, or any of its stream tributaries located between Hoover Avenue and Post Road, except for a motorized vessel equipped with an electric motor. No person may operate,

occupy or use a motorized vessel of any type on Lake Pacawa within the Village limits. The Village Board may elect to waive this subsection for special events.

- B. Subsection A above does not apply to peace officers or rescue units engaged in emergency operations, Village maintenance vehicles operated by Village employees engaged in routine duties, weed harvesting equipment or specifically authorized vehicles.

§ 204-3. Violations and penalties.

Any person who shall violate any provision of this chapter may be subject to a forfeiture of not less than \$10 nor more than \$100, together with the costs of prosecution.
