WHEREAS, the Douglas County Forest, Parks and Recreation Committee, recommends renaming Bardon Lake to Whitefish Lake to resolve a long standing naming discrepancy with the Wisconsin Geographic Names Council (WGNC) and the U.S. Bureau of Geographic Names, and

Sections Three (3), Four (4), Nine (9), Ten (10), Sixteen (16), Seventeen (17), Twenty (20), and Twenty-one (21), Township Forty-three (43) North, Range Twelve (12) West, Town of Wascott, Douglas County, Wisconsin, and

WHEREAS, the WGNC is a subset of the Wisconsin Department of Natural Resources (WDNR) and is responsible for authorizing official name changes of geographic features in the State, and

WHEREAS, in February of 1975, the WGNC received a proposal from the then President (Martin A. Rieschl) of the Whitefish Lake of Douglas County Property Owners Association, Inc., to rename Bardon Lake to Whitefish Lake, and

WHEREAS, in October of 1975, the WGNC approved said name change, and

WHEREAS, said name change was never officially recorded with the U.S. Bureau of Geographic Names to maintain consistency in map production and lake naming purposes, and

WHEREAS, this resolution will hereby officially record the County's approval of said name change allowing the WDNR to meet the local municipality approval requirements of the U.S. Bureau of Geographic Names to facilitate such name change.

NOW, THEREFORE, BE IT RESOLVED that the Douglas County Board of Supervisors accept the recommendation of the Forest, Parks and Recreation Committee and hereby approves officially renaming the Bardon Lake described herein to Whitefish Lake.
