

QUARTERLY REPORT – 2ND QUARTER 2025

WDNR - WCWRPC AID AGREEMENT For the update of the Chippewa Falls-Eau Claire Urban Sewer Service Area (SSA) Plan

Project Goals

Update the SSA Plan for the Chippewa Falls-Eau Claire Urban Area, which includes:

- Applicable content and plan structure described within NR 121.04 and NR 121.055, including brief discussion of water quality standards/impairments and references to other related water quality management plans and policies.
- Incorporate environmental justice and climate resiliency implications & considerations.
- Update 20-year forecasts and facility plan data.
- Update the 20-year SSA Plan boundary.
- Fine-tune environmentally sensitive area (ESA) definitions, as needed.
- Review and update SSA Plan goals, policies, and procedures, including future related applications, amendment processes, tracking/reporting, and plan monitoring.
- Educate on SSA Plan purpose and policy compliance.

<u>Progress this Quarter (4/1/25 – 6/30/25)</u>

- Conducted meeting #5 with Water Quality Management Technical Advisory
 Committee (WQM-TAC), which focused on reviewing the environmental sensitive area
 survey results and fine-tuning the Plan's goals, objectives, and policies. Data related to
 wastewater and stormwater facilities were also reviewed.
- Webpage for plan update information maintained.
- WCWRPC continued with data collection and the development of the SSA Plan sections, including follow-up with sewered municipalities for facility plan, permit, and capacity information.
- Land use and growth projections continued to be on hold as we wait for Wisconsin DOT to incorporate recently updated State population projections into traffic analysis zones (TAZs) for the SSA Plan analysis. This is now expected to be completed by the end of July 2025. WDNR has granted an extension on this project until the end of 2025 to allow time for WDOT's work.

Problems/Issues

• An extension was granted to allow additional time for WDOT to integrate WDOA population projections into the traffic analysis zones (TAZ). WCWRPC is continuing to adapt the project timeline to accommodate this delay.
