I tried to duplicate the latitude and longitude for the John Fendryk Farm (substitution for the Marinette Cnty-Zeitler CY 2009 grant application), now with Grant No. TRC-GN08-38000-09 E.

The lat/long on the Final Report you sent (copy attached) lists the Town 31 North, Range 20 East, Section 30, in the NE 1/4 of the NW quarter, and

latitude: 45 degrees, 8 minutes, 8 seconds longitude: 87 degrees, 3 minutes, 28 seconds.

However, that seems to place, according the DNR's WTViewer, in Township 31 North, Range 28 East, Section 26--in Lake Michigan!! (are we now doing "aqua-" instead of agri-culture:)??)

I believe the most probable latitude and longitude for "Town 31 North, Range 20 East, Section 30, in the NE 1/4 of the NW quarter" would be

latitude :45° 7' 58.9" N,

longitude: 88° 3' 28.8" W -see attached maps.
