# AIS ACTIVITIES June - July, 2009

LCC Meeting, 07 Aug 09

## Outreach/Workshops/Field Work:

- June 6 <u>Kid's Fishing Day</u>, NGLVC Exhibitor Education of AIS to 382 children and 257 adults!
  Had a hands-on activity, take-home activity sheets, tattoos for children, and plenty of material to
  pass out. Danny Benzel of Iron County was also present to show an AIS education video he
  created. He is a high school student at Mercer High as well as the Charter School and did this as a
  special project. He assisted Stefania a great deal during this event.
- June 11 <u>Landowners</u> along Hwy 13 to Bayfield Dropped off educational material for property owners and talked to 2 landowners about the Japanese Knotweed along the road on their property.
- June 12 <u>Knotweed Knockout</u> City of Bayfield. Treatment of Japanese Knotweed in Bayfield.
- June 25

   Citizen Lake Monitoring Network, <u>AIS Monitoring Workshop</u>, Iron River Community Center; Jane Swenson, Iron River, helped with training. 6 attendees.
- July 11 <u>CBCW Workshop</u> Namakagon Town Hall. Trained 3 members of the board of the Namakagon Lake Association for watercraft inspection. Gave them start-up materials for a CBCW program.

## **Conferences/Trainings:**

- June 19 <u>Northwest Wisconsin Lakes Conference</u> Telemark Resort. Set up displays for Bayfield Co. AIS Project and the Northwoods Cooperative Weed Management Area. Conference attendees appreciated the live specimens of EWM and Northern Milfoil to Nan Olson, Chair, AIS Committee also attended. Attendees also took tons of terrestrial invasive species information from the NCWMA table.
- June 24 Performed <u>CBCW on-the-job-training</u> Kreher park. Continued the training of the two WDW CEP Summer Youth Program watercraft inspectors—and are known as part of the "Water Force." There are 55 inspectors across the state; Michelle Johnson is the one for Bayfield County, Crystal Norby for Ashland County.
- July 1 took Michelle Johnson around the Bayfield Peninsula's landings and introduced her to some county individuals and Marina owners. Arranged for her to piggyback with some Sea Grant Watercraft inspectors for extra training and confidence-building.
- July 18 <u>Project RED Workshop</u> NGLVC. Participated in a Riverine Early Detection training to be able to help propagate this monitoring program to county river users.

#### Meetings:

- June 8 NCWMA meeting NGLVC
- June 18 met with Matt Bushman, USDA Forest Service, and Carmen Chapin, US Park Service, to review applications for the Coordinator position for NFWF/NCWMA grant
- June 18 Met with state AIS professionals and WI Dept. of Workforce Development supervisors to initiate the Summer Youth Program work supervisor process and met the young ladies who will assist Ashland and Bayfield County with watercraft inspections on Lake Superior.
- June 20 Barnes Town Hall Sandbar and Tomahawk homeowners meeting regarding the WDNR/US Army COE treatment study on the lakes. After first year of treatment—an unprecedented 100% die-off of Eurasian Water-milfoil. Another unexpected result—even though chemical concentration was applied ¼ of the recommended dose, chemical stayed in the water much longer than anticipated and therefore affected native plants. ## **Grant Administration/Grant Updates:**

- The first WDNR AIS Control Grant ended 30 June 2009. Presently collecting match paperwork and receipts to submit final reimbursement request and final report.
- County AIS Project expenses now running under the 2009 WDNR AIS grant.
- AIS Control Grant submitted to WDNR for AIS programs in the Iron River and Delta Areas (including county parks) for FY for 2010 2011.
- 1 July started the Coastal Management Grant AIS School Education Project.
- NCWMA/NFWF Grant Coordinator hired Darienne McNamara

### Other Activities:

Put together an AIS Project display for the NW Lakes Conference highlighting the success of the county's program; networked with county and partners about the NCWMA Coordinator position. Scheduled Michelle for watercraft inspections and was available for questions/feedback. Networked with Iron River Area Lakes Association on smaller projects on the Pike Chain of Lake. Networked with Namakagon Lake Association and Diamond Lake Association on grant information, landing signage, and other AIS information. Laid to rest (hopefully) the controversy around fishing tournaments on Lake Namakagon.
