

I. OVERVIEW

The Town of Neenah developed a parking control ordinance to supplement its street sweeping program. The parking control ordinance prevents landowners from parking vehicles along urbanized Town streets during street sweeping operations, but not along rural Town streets. Based on scientific research, the stormwater quality benefits of the street sweeping program are significantly greater if parked vehicles do not restrict the street sweeper's access to the concrete curb and gutter. A significant portion of sediment, phosphorus and other stormwater pollutants accumulate within a few feet of a street's concrete curb and gutter flow line. A copy of the street sweeping / parking control ordinance is provided in Appendix A.

APPENDIX A

STREET SWEEPING ORDINANCE

MUNICIPAL CODE OF THE TOWN OF NEENAH, WINNEBAGO COUNTY, WI CHAPTER 4

TRAFFIC CODE

4.05 NO PARKING DURING STREET SWEEPING OPERATIONS

- (1) No parking is permitted on Town streets with curb and gutter on refuse collection days from 7:00 a.m. to 5:00 p.m. between April 1st and November 15th. The refuse collection schedule is posted on the Town website and at the Town Hall. The intent of this provision is to enable street sweeping curb to curb on refuse collection days.
- (2) In the event that a vehicle is found in violation of any provision of this chapter relating to parking of vehicles, under circumstances wherein the person who parked the vehicle is unknown, it shall be presumed that the owner of the vehicle authorized, allowed or permitted the vehicle to be so parked.
- (3) Any person who violates this ordinance shall be subject to a forfeiture of \$15.00, if such forfeiture is paid within five (5) days after the offense. After five (5) days from the date of the offense, the forfeiture shall be \$30.00, and after fifteen (15) days from the date of the offense the forfeiture shall be \$45.00. Each day or part thereof that a violation of this Section occurs shall be deemed a separate violation.
- (4) Any vehicle parked in violation of this ordinance shall be towed at the owner's expense.
