Below is a marketing aid FOTSCH developed to explain the Canoes On Wheels program and to document its success over the past few years.

The Canoes on Wheels ("COW") program puts kids into canoes to help them find their passion. We work with middle and high school aged students through their schools and youth organizations.

The volunteer staff of COW offers the use of a canoe trailer, eight canoes suited for river or lake use, and canoe gear such as paddles, life vests, and aquatic plant visual field guides at no-cost to local schools and youth groups. COW also provides no-cost workshops for teachers to help them understand how to safely manage canoe outings and to integrate these activities into school curriculums. When requested, the COW program offers logistical support such as trailer transport.

Started in the fall of 2008, the COW program has a proven track record. Our canoes have been on five northwestern Wisconsin rivers and numerous lakes.

Donations to the COW program are used for direct operational expenses such as insurance, winter storage costs, outing supplies, and transportation costs.

School classes, 4-H camps, and student outdoor education camps all benefit from the COW program. We believe at least 30% of local youth will not have the opportunity to experience a "rivers-eye" view of our great Wisconsin waterways without this program.

FOTSCH has helped to host county-level workshops, regional gatherings, and most recently a Heritage Summit. The next step is the development of a feasibility study and application to be prepared for congressional review.

Our efforts to partner with the National Park Service (NPS) have significantly increased over the last several years. This effort started when Eurasian Water-milfoil (EWM) was found in the area just above the Gordon Dam. The Gordon/St Croix Flowage Association funded an effort to search for and remove EWM above the dam and FOTSCH began working with the NPS to coordinate work done below the Gordon Dam.

As a result of this effort a strong friendship grew and the NPS invited FOTSCH to accompany them on several St. Croix National Scenic Riverway paddles in 2011. One of these paddles was on the upper reaches of the Namekagon River, and during that paddle a discussion arose regarding the fact that there was no citizen-based "Friends" group in existence for the Namekagon River. At the next FOTSCH board meeting this fact was discussed and we decided to begin an intensive outreach effort to find local people (in Hayward, Seeley, and Cable) who were interested in their river to help them set up a new river group which would look after the Namekagon River and its watershed. This has been successfully done and FOTSCH is very pleased that the Namekagon River Partnership (http://namekagon.org/) now exists as a 501(c)(3) conservation organization with 70 members. FOTSCH continues to be represented on their board and provides administrative support such as hosting their website.

Namekagon River Partnership has already sponsored two very successful river cleanup events in partnership with the National Park Service. The first was held in the spring of 2012 with approximately 40 participants. The most recent river cleanup took place on April 27, 2013 with 70 participants (<u>http://namekagon.org/?p=1146</u>). This went on even with ice still on Lake Namakagon and a foot of snow still present at the Big Bend Landing. FOTSCH is very proud of this success and will continue its efforts to expand awareness and protection of the northern portion of the St. Croix Basin.

In closing, we (the FOTSCH board) want to thank you for providing us with this opportunity to continue to understand and protect this wonderful area.

for the citizen-stewards in our watershed to get together and share their experiences in the efforts to identify and control the aquatic invasive species found in the Upper St Croix – Eau Claire Rivers Watershed (see attachment A for a list and location of invasives found.) As a follow up to this meeting, FOTSCH scheduled a Douglas County Land Conservation Committee (LCC) on June 18 to review what we have learned about the aquatic plants in our watershed over the past several years and more specifically which aquatic invasive species have been found.

During the last few years FOTSCH has been working hard to spread the word about our natural resources, and we have learned that to gain the interest of local citizens it is very important to focus the discussions on features local to each community. People seem to engage more when we relate what we are learning from the studies to things that are happening in their own back yard. One of our goals is to increase FOTSCH's visibility within our local communities, communicate effectively with the public, as well as to establish and strengthen partnerships.

One example of this idea of focusing on a specific "Neighborhood" occurred on April 16, 2011. Our consultant, Matt Berg, completed his survey of the Ox Lakes and he agreed to do a community presentation for us. The title of the talk was: The Ox Lakes - Two Ecological Jewels in the St. Croix Watershed Crown. Slides of this presentation can be found on our website (www.fotsch.org/?page_id=125). In addition to running an ad in the Northwood Shopper we also conducted research to identify property owners in and around Upper and Lower Ox Lakes, and Ox and Mud Creeks and surrounding area. We then prepared a mailing, typed envelopes and used the postal service to mail to over 100 property owners regarding the upcoming Ox Lakes presentation. As a result we had a very good turnout over 30 people mostly property owners.

We continued our efforts to spread the word regarding the information that was being gathered in our watershed by scheduling presentations with the Solon Springs Village Board (April 25, 2011), Solon Springs Town Board (May 9, 2011) and a Solon Springs community presentation (June 18, 2011). The PowerPoint presentation used at these presentations is attached.

In conclusion, with the help of this grant FOTSCH was able to make significant progress on the goals which were outlined in the Board Retreat held in August of 2008. We have increased the visibility of FOTSCH and the northeast reaches of the larger St. Croix River Basin by participating in two significant activities. The first was the St Croix River Association (SCRA) At Croix Paddle in July of 2011. As plans progressed FOTSCH agreed to get the permissions necessary for and "Opening Ceremony" which would be held at Lucius Woods County Park in Solon Springs the day before the paddle began. We also organized the first two days of the paddle making arrangements for campsites etc.

The second activity is the National Heritage Area Initiative that focuses on the 7,700 square-mile St. Croix River Basin (<u>http://www.stcroixheritage.org/</u>). These planning discussions began over two years ago and are still going today. Task force meetings are usually held in St. Croix Falls and FOTSCH's presence at these meetings provides a

Combining this information with that which was collected under several other DNR funded grants (listed below), we now have a much more complete understanding of the invasive and non-invasive aquatic plants in our watershed. DNR grant RP-180-10, which funded the 7-mile portion of the Upper St. Croix River, a 2005 DNR grant funded aquatic plant surveys in the Eau Claire Lakes area and a 2007 DNR grant funded an aquatic plant survey of the St Croix Flowage.

Another consultant, Valerie Haack, has delivered 20 copies of a second aquatic plants visual field guide focusing on 89 plants found in our watershed. This field guide is titled <u>Comprehensive Guide to Aquatic Plants of the Upper St. Croix</u> and it contains beautiful high-resolution color images of 92 different plants, with notes that will aid volunteers in their efforts to identify the aquatic plants that they find. Where possible, there is also a page number reference to a more extensive guide called <u>Through the looking Glass: A</u> <u>Field Guide to Aquatic Plants.</u> Twenty more copies of the original field guide developed under grant RP-180-10 were also purchased. This original field guide titled <u>Introductory Guide to Aquatic Plants of the Upper St Croix</u>, introduces citizen scientists to aquatic plants commonly found in our watershed. Both field guides have been successfully used on canoe outings (see attachment for a list of dates and outings) where the field guides were routinely soaked in water at the bottom of the canoe, but because each page is laminated, the books survived, none the worse for wear, and with the use of a dry cloth were ready for their next outing.


In order to get these books in the hands of volunteers, FOTSCH sponsored an Upper St Croix Watershed Alliance (USCWA) meeting in November of 2011. At this meeting FOTSCH distributed a copy of each of these field guides to the Lake Associations attending that meeting and we hear they are being put to good use.

We have found only two drawbacks which are now holding us back from a much wider distribution of these wonderful plant books: cost and their physical weight. To address these two issues FOTSCH is currently researching whether a "plastic" paper and waterproof ink can be used to print these books. This would eliminate the need to laminate each page after printing, which would significantly reduce the production cost and also reduce the weight of the books. So far we have been unsuccessful - but we are still looking.

In the winter of 2012/2013 FOTSCH asked our fellow USCWA partner, the Eau Claire Lakes Area Property Owners Association (POA), if they were interested in helping FOTSCH host a spring 2013 AIS conference in Barnes. Ted Eastlund brought this idea to their board and got an enthusiastic approval to co-host the event. Planning continued through early April. An ad was placed in the Northwood Shopper.

As it turned out our April 20th conference happened in spite of the foot of snow that fell the day before. We had about 35 people at the conference with presentations which included two school groups (Joanne Zosel and her students from Solon Springs High School and Matthew Berg and his students from Grantsburg High School). There were also presentations by Carrie Sanda, the Douglas County AIS Coordinator, the POA and the Gordon/St. Croix Flowage Association. This conference provided a rare opportunity

Grant AEPP-206-10 Summary Report Pilot Aquatic Macrophyte River and Lake Surveys in the Upper St. Croix – Eau Claire Rivers Watershed



During the past few years, with the help of this and other grants, we have been able to do a very thorough scientific study of our watershed. This project was designed to address one of the State of Wisconsin's most immediate needs: the monitoring of our flowing waters to increase our understanding of the spread of invasive species through the vectors (pathways) shown in the map and how they are impacting riparian

ecosystems. More specifically, this project piloted a DNR-authorized river/stream aquatic plant survey method that was developed by our consultant in close cooperation with DNR Departmental staff (see consultants assessment, attached). The goal was that once this protocol was used and the results reviewed, this survey method would be adopted by the DNR and would be made available to other river groups in the State of Wisconsin.

Aquatic Plant Surveys funded under this grant were on AIS pathway #2 (Upper and Lower Ox Creek, and Mud Creek, Upper and Lower Ox Lakes, and Upper St. Croix River and Ox Creek Slough Aquatic Plant Survey) and on pathway #3 (Lower Eau Claire River, and Eau Claire River Flowage) plus Upper St Croix Lake.

- Upper St. Croix River and Ox Creek Slough
- St. Croix River Dive/Boat Surveys (immediately below the Gordon Dam in the St. Croix National Scenic Riverway).
