Dear Mr. Mesbah:

We have completed our review of the subject amendment request that was submitted to the Department on December 18, 2012 by the Capital Area Regional Planning Commission. The Department hereby approves this amendment request which adds 50.7 acres to the Brooklyn Urban Service Area, located east of the village, south of STH 92, and east of South Kerch Street, in the Town of Rutland (See attached Map 1). The proposed amendment includes 3.2 acres of existing STH 92 right-of-way, 10.2 acres proposed for environmental corridors and 37.3 developable acres, which will be used for commercial purposes.

The amendment was requested by the Village of Brooklyn on September 19, 2012; a public hearing was held on November 8, 2012 and the amendment was adopted by the Capital Area Regional Planning Commission per Resolution CARPC No. 2012-7 on November 8, 2012.

The approval of this sewer service area amendment does not constitute approval of any other local, state, or federal permit that may be required for sewer construction or associated land development activities.

If you believe that you have a right to challenge this decision, you should know that the Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions must be filed. For judicial review of a decision pursuant to sections 227.52 and 227.53, Wis. Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to file your petition with the appropriate circuit court and serve the petition on the Department. 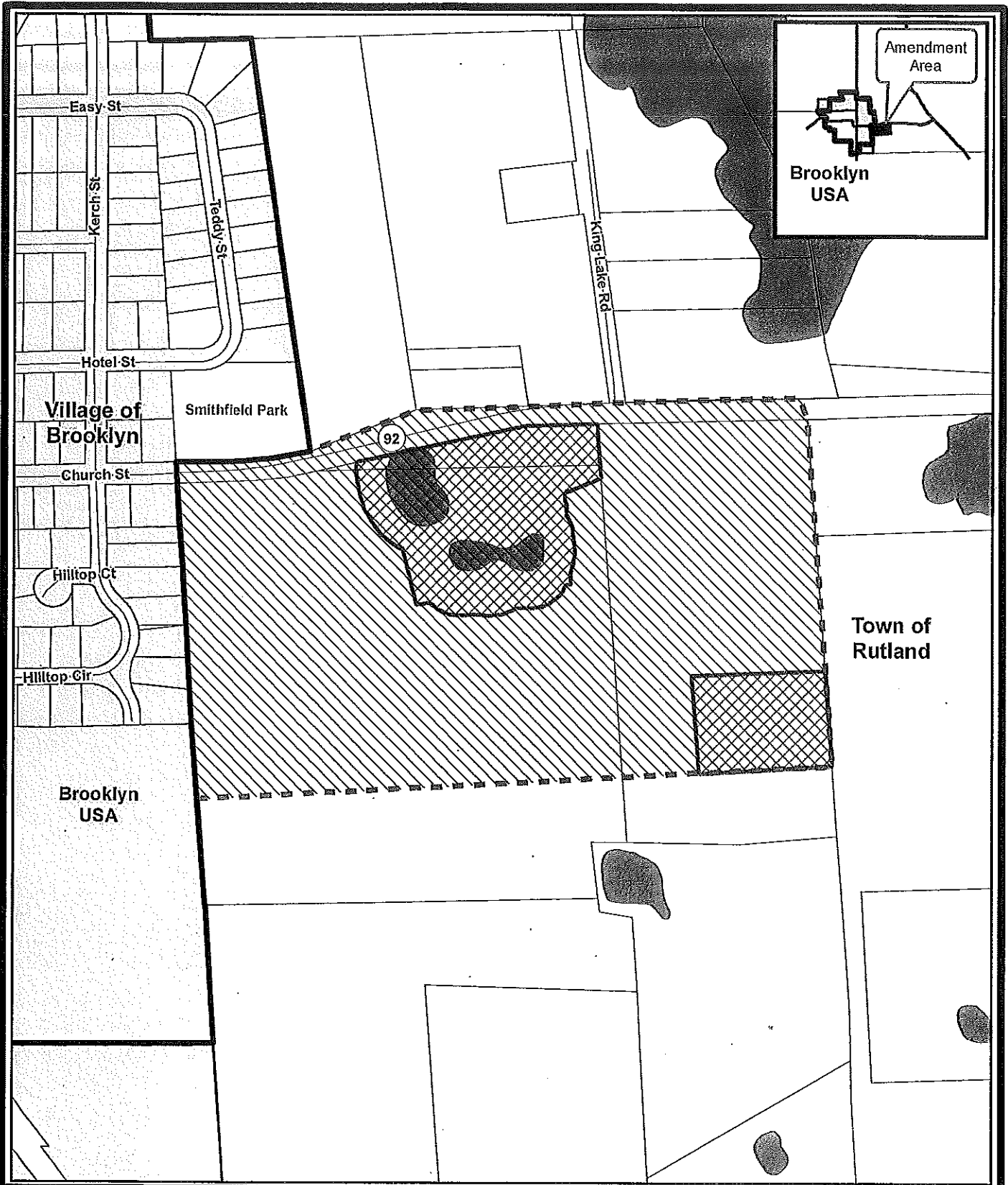




Map 1 Brooklyn USA - Business Park

Subject: Amendment to the *Dane County Water Quality Plan*, Revising the Waunakee Urban Service Area Boundary and Environmental Corridors in the Village of Waunakee

Dear Mr. Mesbah:

We have completed our review of the subject amendment request that was submitted to the Department on February 20, 2013 by the Capital Area Regional Planning Commission. The Department hereby approves this amendment request which adds 14.7 acres to the Waunakee Urban Service Area, located east of Highway Q, in the Village of Waunakee (see Map 1).

The proposed amendment includes 5.7 acres of existing right-of-way (CTH Q), a 4.8 acre property with a church, and a 4.2 farmstead property. The amendment adds 4.2 developable acres to the Waunakee Urban Service Area proposed for commercial, institutional and residential land uses. There is no environmental corridor identified at this time, but the southeastern portion of the parcel shows hydric soils, which are an indicator of wetlands. Before that area is developed, a wetland delineation should be carried out to determine if a wetland permit is needed.

The amendment was requested by the Village of Waunakee on December 19, 2012, a public hearing was held on February 14, 2013 and the amendment was adopted by the Capital Area Regional Planning Commission per Resolution CARPC No. 2013-2 on February 14, 2013.

This amendment becomes a part of the Dane County Water Quality Management Plan and the Lower Rock River Basin Plan and will be forwarded to the US Environmental Protection Agency to meet the requirements of the Clean Water Act of 1987 (Public Law 92-500 as amended by Public Law 95-217), and outlined in the federal regulations 40 CFR, Part 35.

The approval of this sewer service area amendment does not constitute approval of any other local, state, or federal permit that may be required for sewer construction or associated land development activities.

If you believe that you have a right to challenge this decision, you should know that the Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions must be filed. 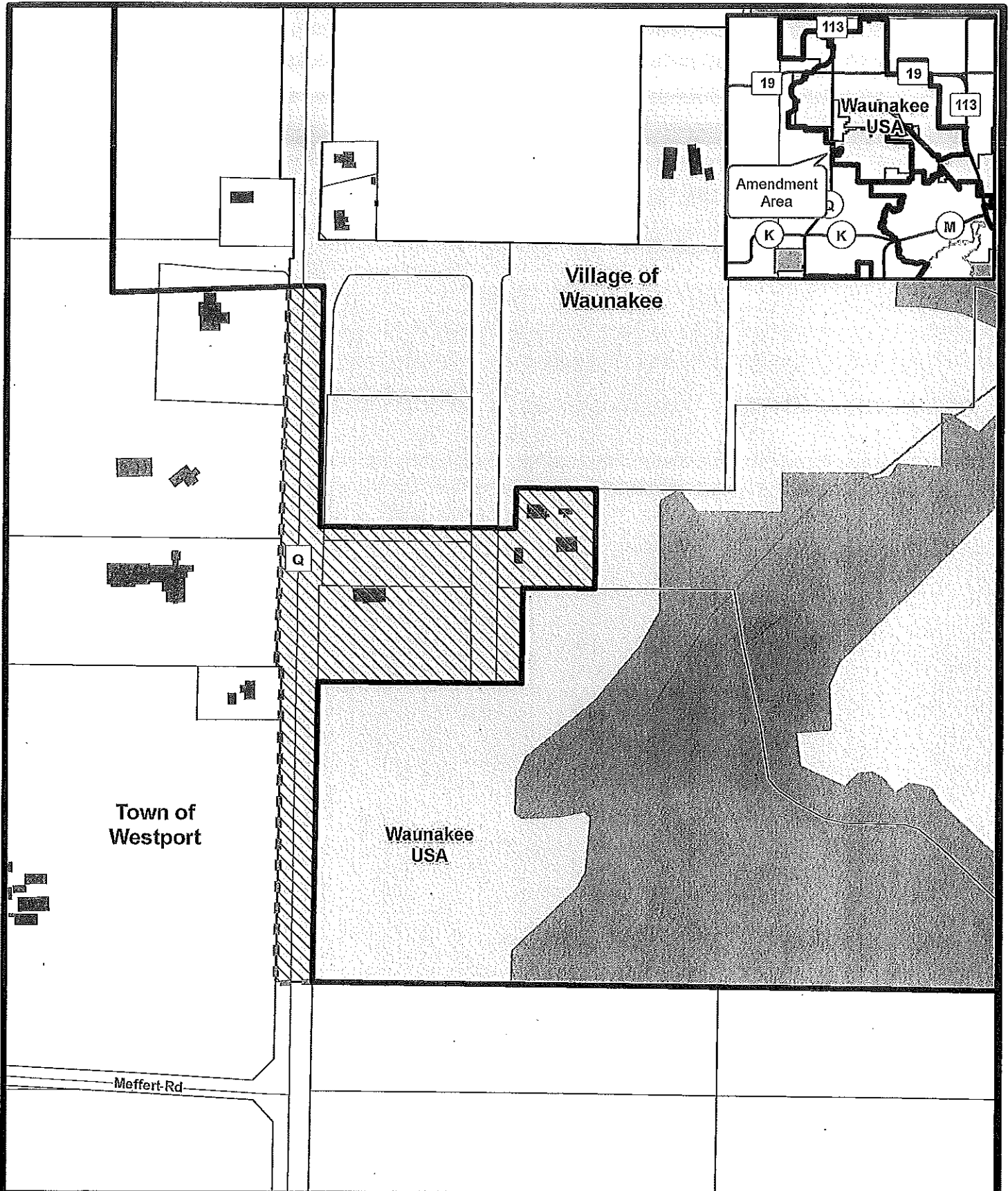



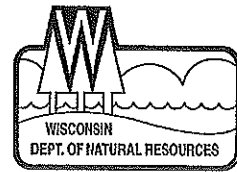

Dear Mr. Mesbah:

We have completed our review of the subject amendment request that was submitted to the Department on April 2, 2013 by the Capital Area Regional Planning Commission. The Department hereby approves this amendment request which adds 3.2 acres to the Central Urban Service Area, located at 7960 Raymond Road in the Town of Verona (see Map 1).

The amendment area will be annexed by the City of Madison. The area consists of 0.3 acre of existing development and 2.9 developable acres. There is no environmental corridor, but only the front 130 feet of 170 to 350 foot deep lots can be disturbed. The remaining portions of these lots will be preserved as private open space through deed restriction.

The amendment was requested by the City of Madison on November 28, 2012, a public hearing was held on February 14, 2013 and the amendment was adopted by the Capital Area Regional Planning Commission per Resolution CARPC No. 2013-3 on February 14, 2013.

This amendment becomes a part of the Dane County Water Quality Management Plan and the Sugar-Pecatonica River Basin Plan and will be forwarded to the US Environmental Protection Agency to meet the requirements of the Clean Water Act of 1987 (Public Law 92-500 as amended by Public Law 95-217), and outlined in the federal regulations 40 CFR, Part 35.



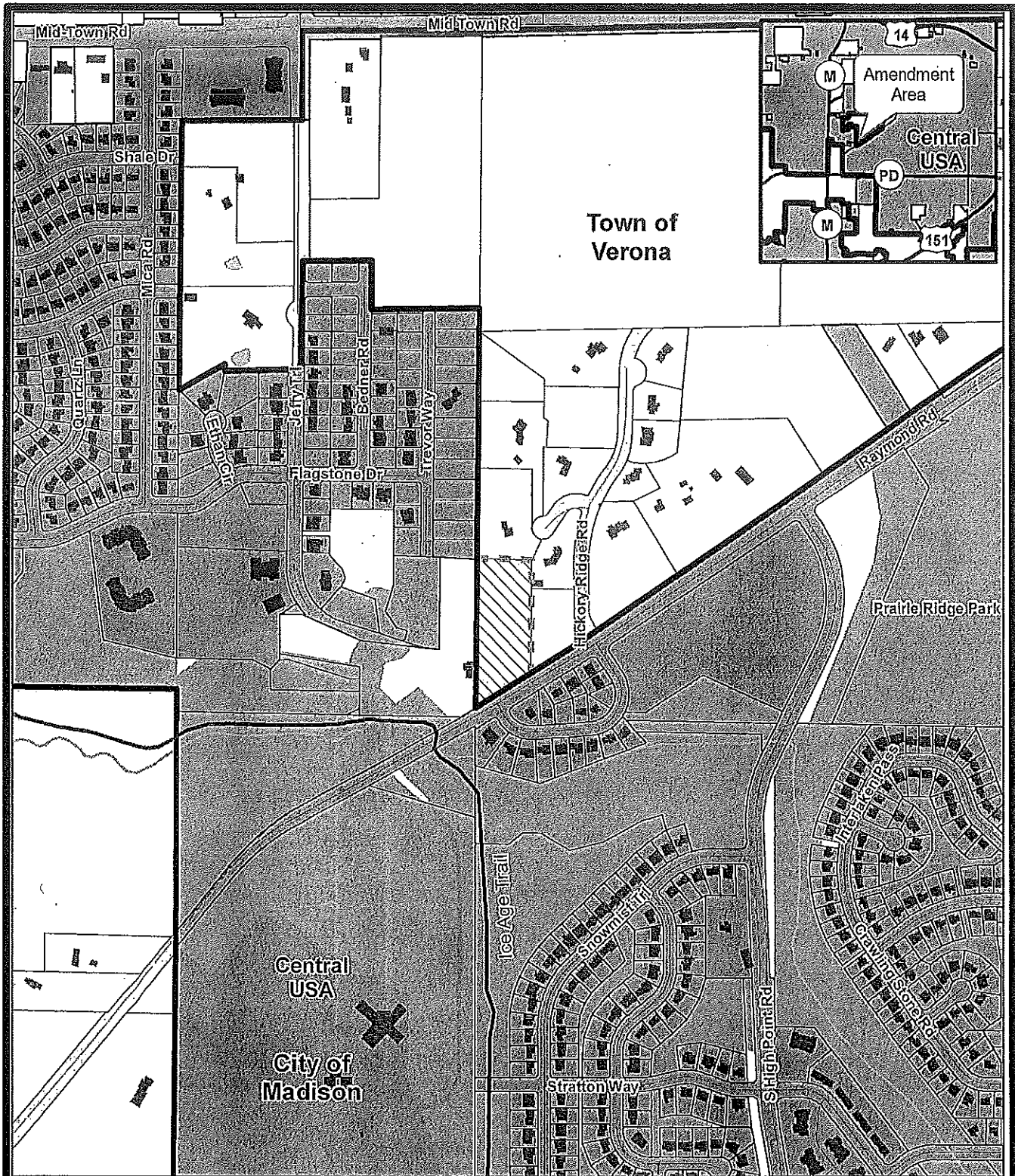




Map 1 Raymond Rd

Amendment to the Central Urban Service Area and Environmental Corridors in the Town of Verona

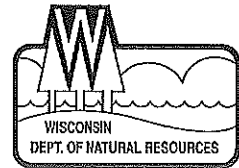

Dear Mr. Mesbah:

We have completed our review of the subject amendment request that was submitted to the Department on March 22, 2013, by the Capital Area Regional Planning Commission (CARPC). The Department hereby approves the Amendment to the *Dane County Water Quality Plan*.

The amendment updates the previous report on this topic prepared by the Dane County Regional Planning Commission in 1998, including a review of the following:

- Revisions to Comm 83 in 2000 (now SPS 383) which resulted in substantial changes to the state administrative rules regulating on-site systems;
- Advances in on-site wastewater treatment systems which have led to systems that can be installed in areas previously unsuitable for in-ground systems, as well as systems that can effectively remove nitrogen;
- Analysis of additional data on nitrate levels in private drinking water wells.

Public hearings were held at CARPC meetings on November 8, 2012, January 10, 2013 and February 14, 2013, to take testimony on the draft. The Capital Area Regional Planning Commission adopted the amendment per Resolution 2012-8 at its February 14, 2013 meeting.

This amendment becomes a part of the *Dane County Water Quality Management Plan* and will be forwarded to the US Environmental Protection Agency to meet the requirements of the Clean Water Act of 1987 (Public Law 92-500 as amended by Public Law 95-217), and outlined in the federal regulations 40 CFR, Part 35.

We have completed our review of the subject amendment request that was submitted to the Department on June 26, 2013 by the Capital Area Regional Planning Commission. The Department hereby approves this amendment request which adds 97.9 acres to the Mt. Horeb Urban Service Area, and deletes 125.7 acres from the Urban Service Area in three areas, two in the Town of Blue Mounds and one in the Town of Springfield (See Maps 1 and 1A).

The amendment addition is located south of STH 18/151 and west of Docken Road and includes 10.5 acres of existing development, 64.1 developable acres and 23.3 acres proposed as environmental corridor. The developable land is proposed to accommodate a new wastewater treatment plant on 11 acres and industrial development on 53 acres.

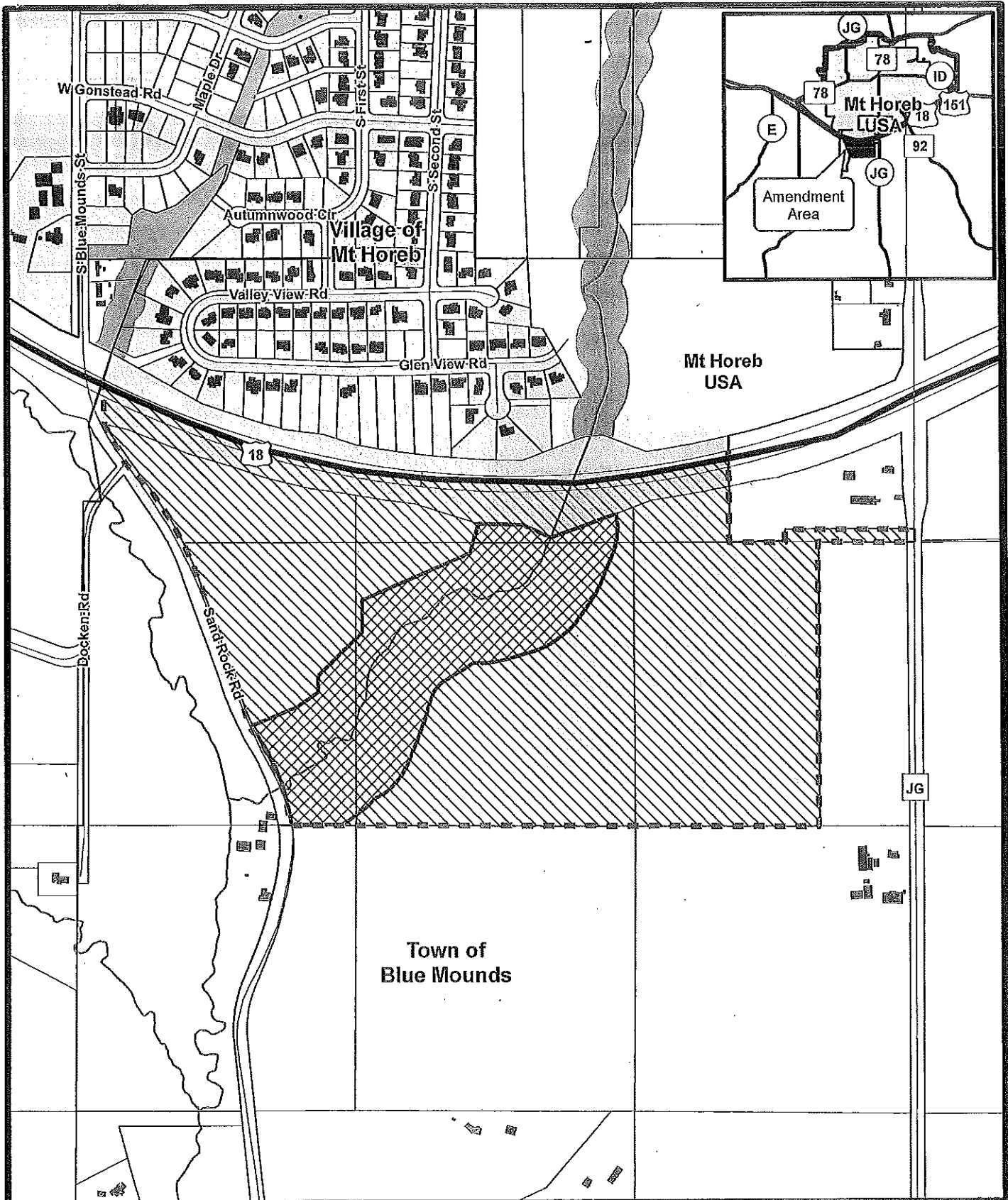

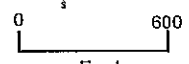

Amendment to the Mt Horeb Urban Service Area and Environmental Corridors in the Village of Mt Horeb

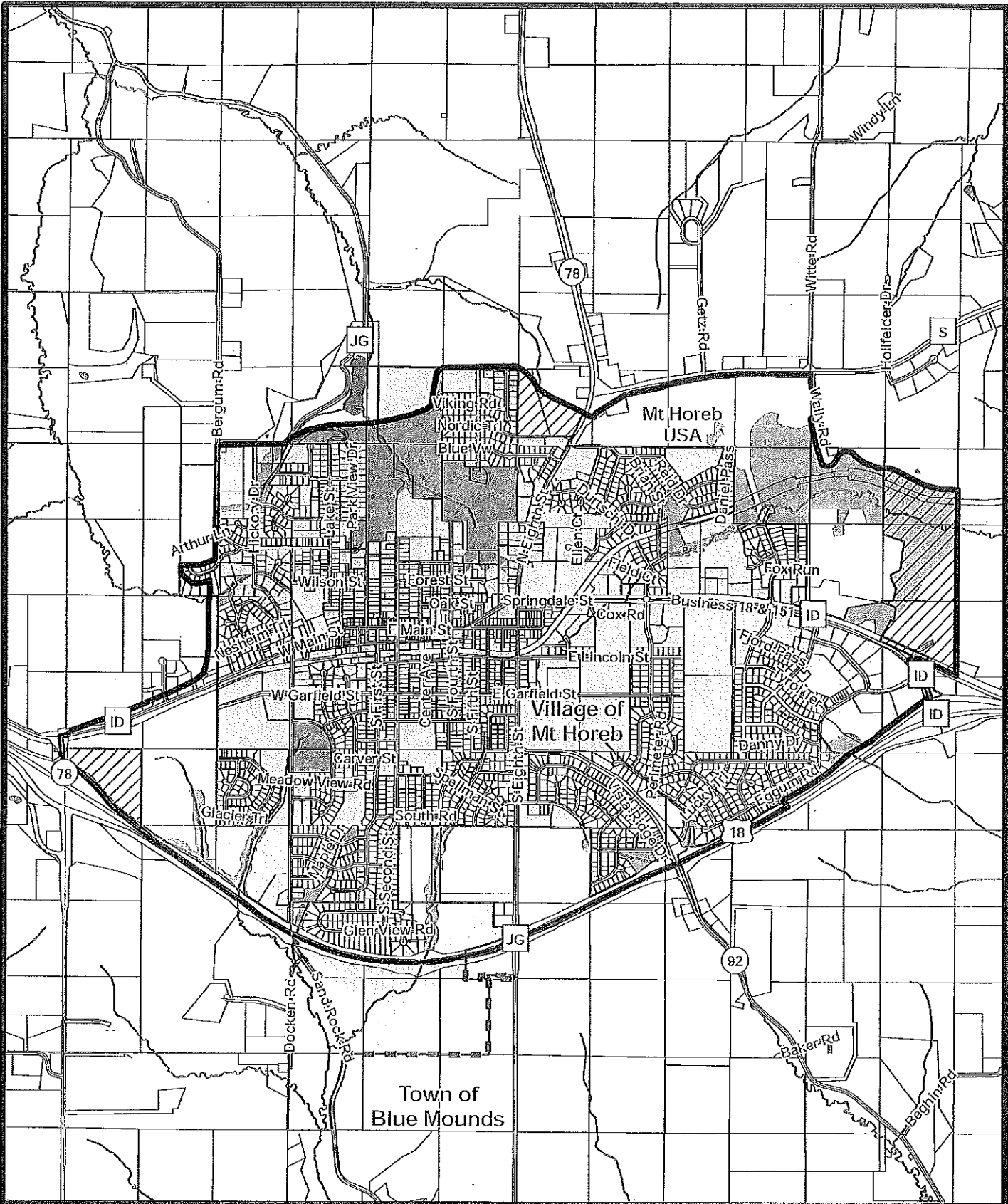

We have completed our review of the subject amendment request that was submitted to the Department on November 15, 2013 by the Capital Area Regional Planning Commission. The Department hereby approves this amendment request which removes 235 acres of agricultural lands from the Dane Urban Service Area. This action allows the Village of Dane to continue to include the lands in agricultural preservation programs as required by changes in the Farmland Preservation laws and the Dane County Comprehensive Plan. The land requested to be removed is in two areas. The first area consists of 95 acres and is located in the northeast section of the urban service area. The second area consists of 140 acres and is located in the south central section of the urban service area (see Map 1 Dane USA Reduction).

Current development patterns and projected population growth were analyzed, and it was concluded that the remaining 140 acres of land available in developable land use categories together with existing residential lots would be sufficient to meet residential development needs for the next twenty years.

The amendment was requested by the Village of Dane on September 18, 2013, a public hearing was held on November 14, 2013 and the amendment was adopted by the Capital Area Regional Planning Commission per Resolution CARPC No. 2013-15 on November 14, 2013.

This amendment becomes a part of the Dane County Water Quality Management Plan and the Rock River Basin and the Wisconsin River Basin Plans and will be forwarded to the US Environmental Protection Agency to meet the requirements of the Clean Water Act of 1987 (Public Law 92-500 as amended by Public Law 95-217), and outlined in the federal regulations 40 CFR, Part 35.
